## REJOINDER TO BARTAMAN NEWS ITEM DATE 21.10.2019

Apropos of the news item dated 21<sup>st</sup> October, 2019 published in the vernacular daily Bartaman under the caption "নেই জুডিশিয়াল মেস্বার, নিয়মিত শুনানি হছে না রাজ্য মানবাধিকার কমিশনে," the Commission deems it proper to issue the following clarification to avoid any misgiving amongst the general public. It is true that Judicial Member ceased to hold office on 7<sup>th</sup> April, 2019 and the vacancy is yet to be filled up. It is not however true that due to the aforesaid vacancy hearing of the complaints or investigation thereof has in any way been affected.

It is also not true that the number of complaints have declined since office of the West Bengal Human Rights Commission was shifted from Bhabani Bhavan.
