Also intimate whether an inquiry under Section 176(1A)(a) of Cr.P.C. has been held by Ld. Judicial Magistrate, if so a copy thereof be sent

ADG, Correctional Services, West Bengal is directed to submit a detailed report along with copy of Post Mortem and Magisterial Inquest report etc., within four weeks from the date of communication of this direction.

This direction is to be communicated forthwith.


