On 20.01.17 this Hon'ble Commission directed the DCP(S.D.), Kolkata to cause an enquiry with regard to the custodial death of one Salim Mistry who died on 12.01.17 at Sambhunath Pandit Hospital and to submit a report and also to intimate whether Inquest by the Judicial Magistrate was done u/s 176(1A)(a) of Cr.P.C. The ADG, Correctional Services was also directed to submit a detailed report along with copy of P.M. report and Magisterial Inquest Report.

It appears that the Superintendent, Alipore Central Correctional Home sent copies of two reports dated 06.05.17 and 01.06.17 enclosing the copies of the available documents like Inquest Report, P.M. report, Death Report, Death Certificate, medical papers, with the report dated 01.06.17 etc. It appears from the copy of the P.M. report that the death was due to effects diseased condition as stated - a natural cause. It is also indicated in the P.M. report that the viscera and blood sample were tagged, labelled and sealed for onward transmission and the whole post-mortem was done under video photography. It appears from the information sheet that the Magisterial Inquiry is under process. It further appears that the AIG(HQ) of Correctional Services sent a report on 05.09.17 informing that the inmate was suffering from chronic liver ailments. The Additional C.P.(II), Kolkata has also sent a report on 07.06.17 informing that the documents were handed over to the authority of Alipore Central Correctional Home. The Additional D.C.P.(S.D.), Kolkata also sent a letter on 17.05.17 informing that the Ld. Court concerned verbally suggested that inquest to be done by Executive Magistrate when a prayer was made for conducting the inquest by any Judicial Magistrate.
