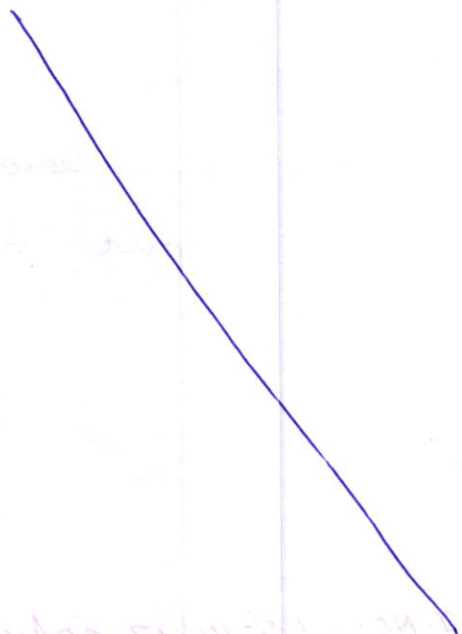

On 20.01.17 the D.C.P. (South Division) was directed to make an enquiry with regard to the custodial death of an ^{UTP} ~~accident~~, namely Khalid Sk. and to submit a report and also to intimate whether request by Judicial Magistrate was done u/s 176(1A) of Cr.P.C. The ADG, Correctional Services was also directed to submit a detailed report along with copies of P.M. report and Magisterial Inquest report.

It appears that the D.C.P. (South Division) forwarded the report on 03.07.17 and the Addl. I.G. (H.A.) of Correctional Services forwarded the report on 05.09.17, ^{but} ~~and~~ both the reports ~~are~~ were tagged with the file only on 18.07.18. However both the reports have been placed before me along with records.

It appears from the report forwarded by the D.C.P. (South Division) that the foresaid UTP was shifted to Sambhu Nath Pandit Hospital from Alipore Central Correctional Home for treatment and ^{he} expired on 12.01.17. The said ~~report~~ facts have been corroborated in the report forwarded by Addl. I.G. (H.A.) Correctional. The copy of the Magisterial Inquest report enclosed herewith

~~speaks about~~, speaks only about a simple injury. The Xerox copy of the death certificate speaks that the death was caused for respiratory failure due to chronic kidney disease. The opinion of the doctor appearing in the P.M. report is that the death was due to the diseased condition of organs as ~~not~~ stated (in the P.M. report).


