Medical College & Hospital on 12.12.2016 at about 23:50 Hrs.

The Dy. Commissioner of Police, Central Division is directed to cause an enquiry and to submit a detailed report alongwith copy of Post Mortem and Magisterial Inquest report etc., to the Commission within four weeks from the date of communication of this order. Also intimate whether an inquiry under Section 176(1-A)(a) of Cr.P.C. has been held by Ld. Judicial Magistrate, if so a copy thereof be sent.

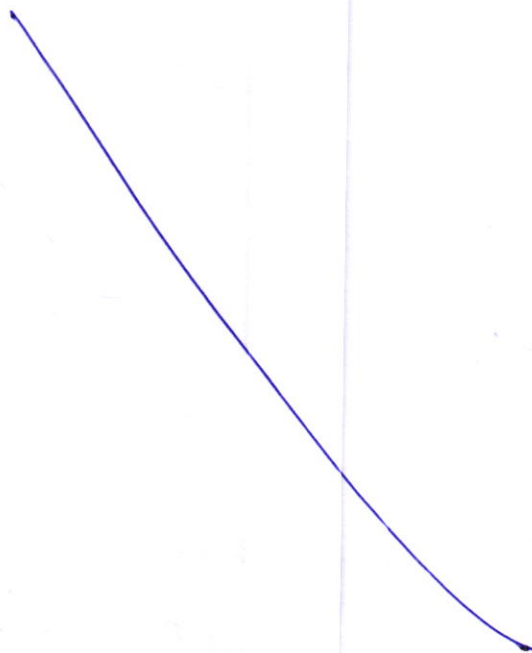

On 03.02.17, the D.C.P. (Central Division) was directed to cause an enquiry about the untodial death of one Ashok Dutta and to submit a ^{detailed} report along with copy Magisterial Inquest report and P.M. report and also to intimate whether an inquiry u/s 176(1-A)(a) of Cr.P.C. has been held by the Ld. Judicial Magistrate and to send a copy of the report if such inquiry be done.

On 30.03.17, the D.C.P. (Central Division) forwarded a report along with copies of Magisterial Inquest report, death certificate and P.M. report. It appears that though the ^{with} report was received by WBHR on 05.07.17 but the same was tagged with the file only on 18.07.18 i.e. after a period of one year. However the same is placed before me today along with records.

It is reported that on 12.12.16 the aforesaid Ashoke Dutta came to the P.S. concerned and confessed that he had murdered his wife and pursuant to his statement the deadbody of his wife was recovered from his house. It is further reported that he also consumed poison and after his arrest, he was admitted at NRS Hospital where he died on 13.12.16.

The copy of Magisterial Inquest report does not speak about any injury and ~~death~~ copy of death certificate speaks that death was due to ²organophosphorus poisoning and the exact cause is to be determined by medicolegal autopsy. It appears from the copy of the P.M. report that the opinion of ~~autopsy~~ the Medical Officer is reserved pending till receipt of chemical examination reports. It is also reported that viscera has been sent to PSL and Magisterial enquiry is pending.
