

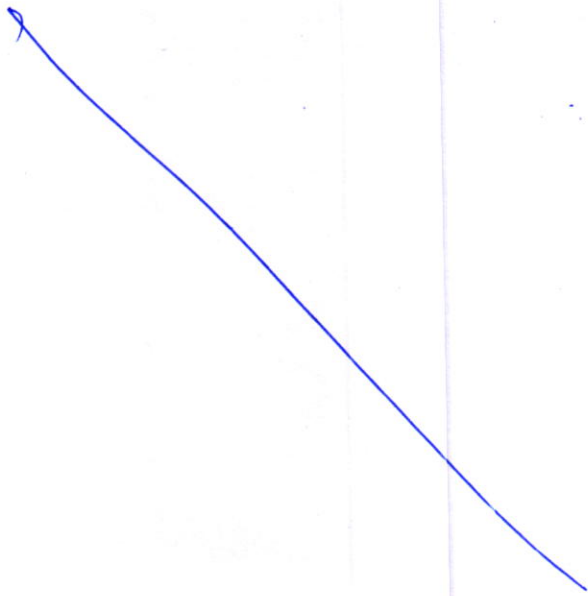

Bangur Hospital and he expired on 07.10.17. It appears from the Magisterial Inquest report that no visible mark of injury was found in naked eyes and in normal day light. It appears ~~from~~ ^{from} from the copy of the P.M. report that death was due to the effects of diseased condition of the body involving vital organs, as ~~noted~~ ^{noted} noted and further opinion will be given after receipt of chemical examination report.

It is further reported that the viscera examination report and Magisterial Inquiry report ~~are~~ are still pending.
