

This direction is to be communicated forthwith.





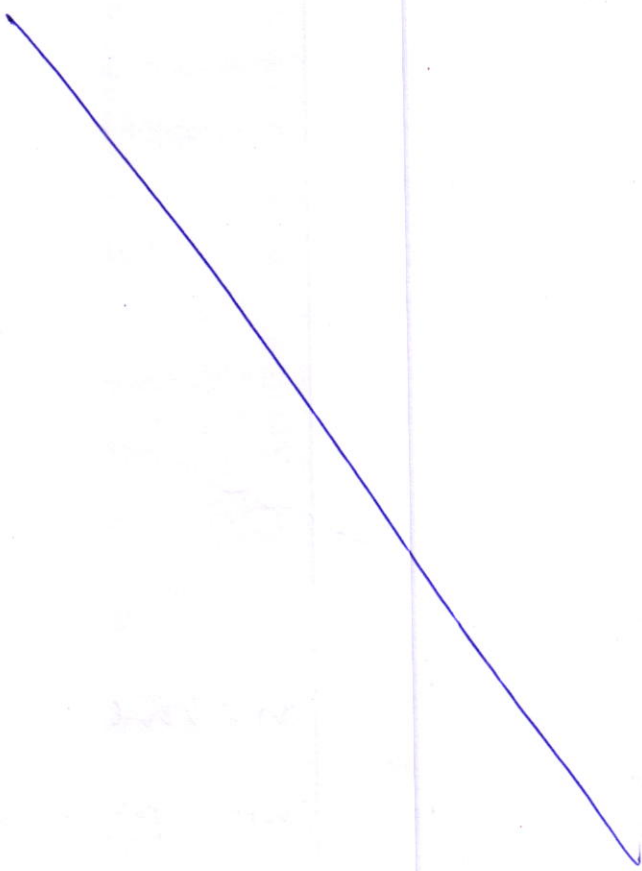

The D.G. Correctional Services was also directed to submit a detailed report along with copy of P.M. report and Magisterial Inquest report.

The different communication, as recorded in the note sheet are nothing but copies of the letters addressed to different authorities and only the letter <sup>dated</sup> 27.04.16 of the S.P. Murshidabad is addressed to WBHRRC.

It appears that the aforesaid letters was forwarded along with copies of P.M. report and Inquest report and also with a video cassette / CD <sup>of</sup> said to be of P.M. examination.

As per Inquest report no injury was found on the body of the deceased.

It appears from the copy of the P.M. report that the opinion of the doctor was kept pending till receipt of chemical Examiner's report.
