

Report of Superintendent Kalna

Subsidiary Correctional Home dt 14.3.18 reveals that UTP Ananda Barui (55 yrs) felt chest pain on 19-12-2017 at about 9.30 PM and sent to Kalna Sub Divisional Hospital at 21.09 hrs but he expired at 22.5 hrs on 19.12.2017. Thereafter CD Case no 203/17 dt 20.12.17 was registered by Kalna P.S. Inquest and Post mortem done accordingly. Report of Ld Magistrate sent to Honorable High Court through the office of Ld ACM Kalna. Verere Report not yet received. As per PM report the cause of death is due to the diseased condition of lungs, a natural cause.
