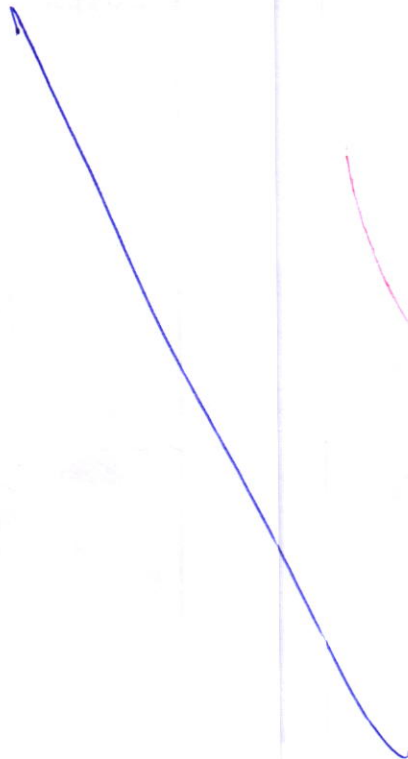

On 22.02.17 D.C.P (E.S.D) was directed to make an enquiry with regard to the untimely death of an UTP, namely Likat ~~Sk.~~ Sk. and to submit a report and also to intimate whether judicial enquiry was done or not. The ADG, Correctional Services was also directed to submit a detailed report along with copies of P.M. report and Magisterial Inquest report etc.

Pursuant to the aforesaid order the D.C.P (E.S.D) Kulkarni and Advt. I. G. (H.A) of Correctional Services have sent their respective reports on 22.08.17 and 29.08.17, enclosing the <sup>copies of</sup> Magisterial Inquest report and P.M. report. It appears from the copy of Magisterial Inquest report that no mark of injury was found on the body of the deceased. It appears from the copy of the P.M. report that death was due to the pathological condition of lungs, ~~as~~ as noted therein, a natural cause.

It appears from the enclosure to the letter dated 22.08.17 ~~sent~~ sent by D.C.P (E.S.D) that the judicial enquiry was done by the Jd. Judicial Magistrate and the viscera of the deceased was sent to FSL on 17.04.17 but the reports were not available till the date of sending the report.

It further appears that the letter of the D.C.P (E.S.D) dated 30.11.17 is nothing but the intimation that the report had already been sent vide letter dated 22.08.17.
