



On 01.03.17, the D.C.P (E.S.D) was directed to make an enquiry with regard to the untimely death of one life convict namely Harishar Chowdhury and to submit a report and also to intimate whether enquiry by Judicial Magistrate was done u/s 176(1A)(a) Cr.P.C. The A.D.G, Correctional Services was also directed to submit a detailed report along with copy of P.M. report and Magisterial Inquest report.

On 20.09.17 Adml. 16(H.Q) of Correctional Services and on 13.10.17 D.C.P (ESD) sent their respective reports which were received by WBHRC on 23.11.17 and 27.11.17 respectively but the same were tagged with the file only on 18.07.18. However the same are placed before me along with records.

It appears from the said reports that the convict was hospitalized from Alipore Central Correctional Home and after shifting from one hospital to another he was admitted at Calcutta National ~~Correctional~~ Medical College & Hospital where he ~~of~~ expired on 27.02.17.

It appears from the ~~the~~ copy of the Magisterial Inquest report that no external injury was found on the dead body of the deceased, As per P.M. report death was due to the effect of the pathological condition of brain as noted therein, a natural cause.

It ^{further} appears from the report of the D.C.P (E.S.D) that Magisterial ~~report~~ Inquest ~~report~~, Judicial enquiry and P.M. examination were done under videography but the video cassette was taken by an warder of sect. It is also reported that Viscera report and Magisterial ~~Enquiry~~ Enquiry report have not yet been ~~obtained~~ obtained.
