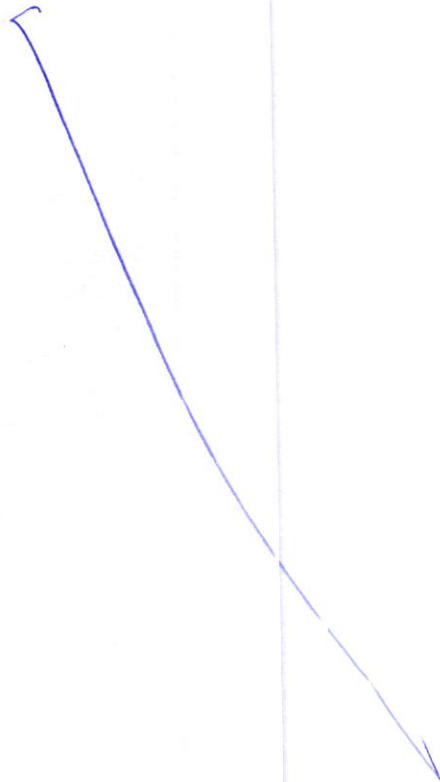

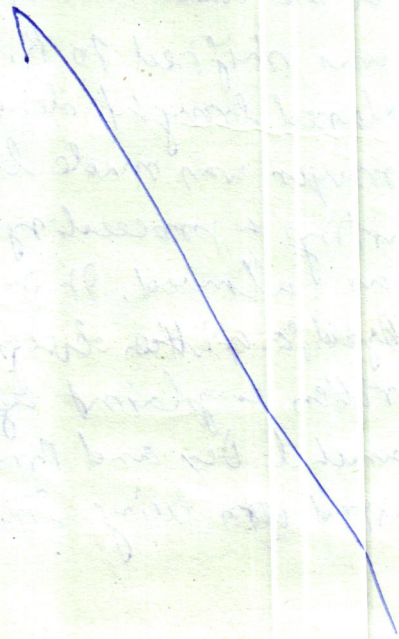

On 27.02.17, the Honble Commission took cognizance from a newspaper reporting that one <sup>who was</sup> ~~old man~~ called at police station ~~for the purpose of~~ <sup>for the purpose of</sup> interrogation, died in the said ~~the~~ police station itself. The D.C.P (North Division) was directed to furnish a report with the address and particulars of the deceased and the statement of his family members as well as <sup>copies</sup> ~~of~~ the P.M. report and R.R.

On 18.09.17 the D.C.P (North & North Suburban Division) forwarded a report which was received by WBHR on 10.11.17 but the same was tagged with the file only on 18.07.18. However the same is placed before me only today along with records.

It is reported that one Monika Roy came to Sinthi P.S. on 26.02.17 under the influence of one Chanchal Dey to lodge a false complaint of ~~against~~ <sup>outraging</sup> of modesty against Snehamon Dey but she withdrew the said complaint vide G.D.E No. 1777 dated 26.02.17. But the said ~~Snehamon~~ Snehamon Dey was called by the duty officer and he became seriously ill at the said P.S. and he was shifted to R.G. Kar Hospital where he was declared brought dead. It is further reported that a prayer was made before the Cd. Comr commenced for starting a proceeding u/s 182 Cr.P.C and such prayer was allowed. It is further reported that later on, the wife of the deceased Snehamon Dey made a written complaint against the said Monika Roy, Chanchal Dey and three others whereby a case was started ~~later~~ <sup>at</sup> Sinthi P.S. case No. 18/17 dated

01.03.17 and the aforesaid Monika Roy and Chanchal Dey were arrested. It is also reported that they were granted bail and the rest of the accused persons were granted anticipatory bail. It is further reported that the investigation is almost complete. According to the report the said Snehamoy Dey was called only for getting some information from him and he was not taken into custody and thus there is no question of custodial death as alleged.

It appears that the address and particulars of the deceased, the statements of his family members, the copies of P.M. report and FIR have not been furnished.
