A Telecom Message dated 25.02.17 has been received from the Superintendent, Dum Dum Central Correctional Home, intimating custodial death of one Bangladeshi Released Prisoner, namely, Suren Pal, aged about 66 years, son of Late Nibaran Pal of Khashkhali, PS-Potuakhali, Bangladesh at the said Correctional Home hospital on 24.02.2017 at about 19:50 Hrs. It is also reported that he was shifted to that Correctional Home from Basirhat Sub Correctional Home on the ground of overcrowding.

The Commissioner of Police, Burrackpur is directed to make an enquiry and submit report to this Commission within four weeks from the date of communication of this direction. Also intimate whether an enquiry under Section 176(1-A(a) of Cr.PC has been held by the Ld. Judicial Magistrate, if so a copy thereof be sent.

On 9<sup>th</sup> March, 2017, the Commissioner of Police, Barrackpore was directed to make an enquiry with regard to custodial death of a Bangladeshi released prisoner Suren Paul and to submit a report and also to send the copy of the judicial enquiry report, if any. The ADG, Correctional Services was also directed to submit a detailed report along with copies of P.M. report and Magisterial Inquest Report.

NOTE SHEET

On 24<sup>th</sup> August, 2017 the C.P., Barrackpore forwarded the copy of P.M. report and the Viscera Examination Report. The copy of P.M. Report is not proper legible and thus the cause of death cannot be ascertained from the P.M. report. It appears from the copy of Viscera Examination report that no poison could be detected either in the Viscera or in the blood of the deceased. On 29<sup>th</sup> Agusut, 2017 the Additional I.G.(H.Q.) of Correctional Services sent an intimation for sending a report after availability of necessary documents and on 6<sup>th</sup> November, 2017 a report was sent by the said authority enclosing the copies of Magisterial Inquest report and P.M. report.

It appears from the photocopy of Magisterial inquest report that there was no mentioning of any mark of injury of the body of the deceased and the apparent cause of death was stated as cardiac respiratory failure as per report of Medical Officer. It is also indicated in the said report that Magisterial enquiry report was yet to be received.
