

This direction is to be communicated forthwith.





On 29.03.17, D.C.P (E.S.D) was directed to make an enquiry with regard to the custodial death of an UTP namely Abdul Gomanari @ Abdul Gomanari and to submit a report and also to intimate whether inquiry by Jd. Judicial Magistrate was done u/s 176(1A)(a) of Cr.P.C. The ADG, Correctional ~~Services~~ Services was also directed to submit a detailed report along with copies of P.M. report and Magisterial Inquest report.

On 28.11.17, Adll. S.G (HQ) of Correctional Services West Bengal sent a report which was received by WBHR on 08.12.17 but the same was tagged with the file only on 18.07.18. However the said report is placed before me today along with records.

It is reported that the said UTP died at Calcutta National Medical College Hospital on 26.03.17. As per Magisterial Inquiry report, no mark of injury was found on the dead body of the said UTP. As per P.M report, the death was caused due to the effects of the diseased condition as noted - a natural cause. It is further reported that the verura report is yet to be received.
