On 12.05.17 this Hon'ble Commission directed the DCP(ESD), Kolkata to cause an enquiry with regard to the custodial death of one Dhaneswar Roy who died on 25.04.17 at Calcutta National Medical College & Hospital and to submit a report and also to intimate whether Inquest by the Judicial Magistrate was done u/s 176(1A)(a) of Cr.PC. The ADG, Correctional Services was also directed to submit a detailed report along with copy of PM report and Magisterial Inquest Report.

It appears that the Superintendent, Alipore Central Correctional Home sent two reports dated 25.07.17 and 08.11.17 enclosing the copies of the available documents like Inquest Report, PM report, Death Report, Death Certificate, etc. It appears from the copy of the PM report that the "death was due to effects of injuries, ante-mortem in nature" as noted therein. It is also indicated in the PM report that the viscera and blood sample were tagged, label and slip for chemical examination through local PS and the whole Post Mortem was done under video photography. It appears from the information sheet that the Magisterial Inquiry is under process. It further appears that the AIG(HQ) of Correctional Services sent a report on 30.11.17 informing that the video cassette of PM examination have been submitted to NHRC and the viscera examination report is yet to be received by the Superintendent, Alipore Central Correctional Home. The DCP(ESD), Kolkata has also forwarded a report on 03.01.18 informing that the FSL report is still awaited.
