

On 17.05.17, D.C.P (E.S.D) was directed to make an enquiry with regard to the custodial death of a convict namely Bhalu Singh Sardar and to submit a report along with copy of judicial enquiry report, if any. The ADG Correctional Services was also directed to submit a detailed report along with copies of Magisterial Inquest report and P.M. report.

On 03.01.18 the D.C.P (ESD) forwarded a report informing that the documents related to the ~~of~~ ^{the} custodial death of the aforesaid convict had been delivered to the correctional Home Authority but nothing has stated about the judicial enquiry. It has been further informed that FSL report is still awaited. However it appears from the copies of death certificate, Magisterial Inquest report and P.M. report forwarded by the correctional Home Authority on 02.03.17 that the aforesaid convict died at Calcutta National Medical College & Hospital on ~~04.05.17~~ 04.05.17 and at the time of Magisterial Inquest only abrasion ~~was~~ ^{was} found on left shoulder, left arm and left knee and the opinion of the doctor as per P.M report is that the death was due to bad effects of the diseased condition as noted - a natural cause and further opinion is reserved till the receipt of chemical examination report and histopathological report.
