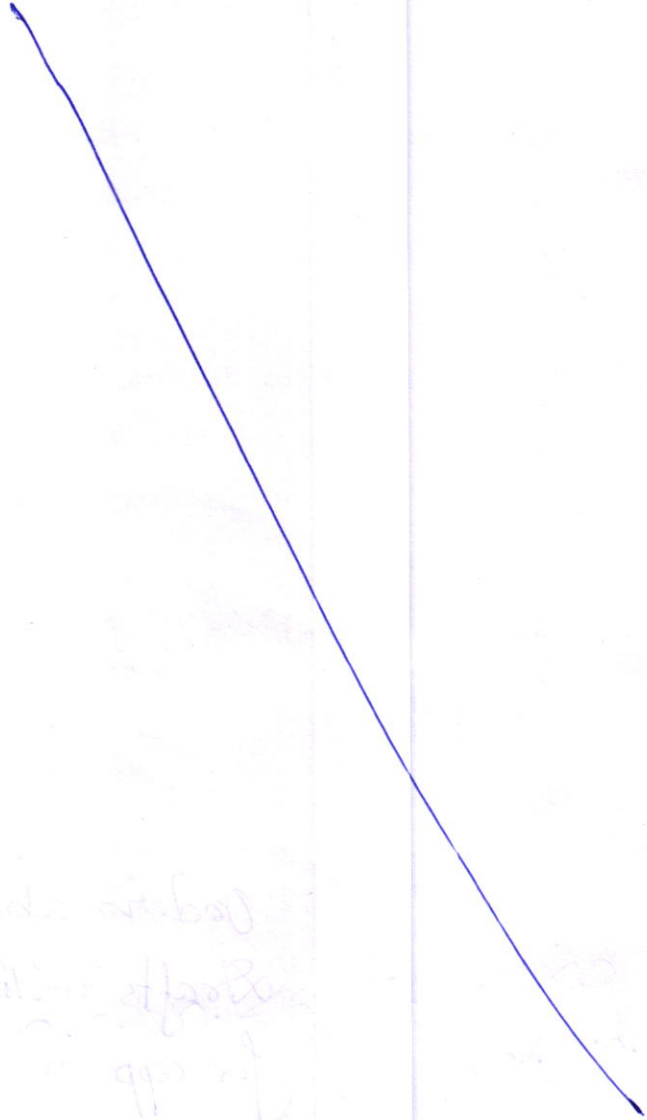

The ADG, Correctional Services was also directed to submit a detailed report along with P.M. report and Magisterial Inquest report.

It appears that a copy of the letter dated 06.10.2017, along with copies of information sheet death certificate, P.M. report, Inquest report, medical papers and medical reports, ~~was sent~~ ^{was sent} by the Superintendent Presidency Correctional Home and a copy of further letter dated 16.04.2018, along with the copy of Magisterial Inquiry report, was sent by the said authority. In the mean time the Ad. C.M.M., by forwarding a letter dated 16.03.2018 sent the self same copy of the Magisterial Inquiry report directly to this Honble Commission. The D.C.P. (S.D), Kolkata also sent a report informing that the original documents were sent to the Presidency ~~cor~~ Correctional Home Authority and only some copies thereof were annexed with the said report.

It appears from the P.M. report that the opinion as to the cause of death is pending till the receipt of chemical examination and histopathology report. As per Magisterial Inquiry report there is no apparent foul play resulting the death of the convict pending histopathological report.
