The said reports were received by WBHRCL in the month of November 2017 but the same were tagged with the file only on 18.07.18 and placed before me today.

It appears from the xerox copy of the Magisterial Inquest report that no mark of injury was found over the body of the deceased and no emaciated body appeared to have been suffering from malnutrition.

It appears from the xerox copy of the P.M. report that the death was caused due to the effects of diseased condition of organs noted thereon being natural cause.

It further appears from the report dated 03.11.17 that Visura Examination report and Magisterial Enquiry report are yet to be received.
