Also intimate whether an enquiry under Section 176(1-A(a) of Cr.PC has been held by the Ld. Judicial Magistrate, if so a copy thereof be sent.

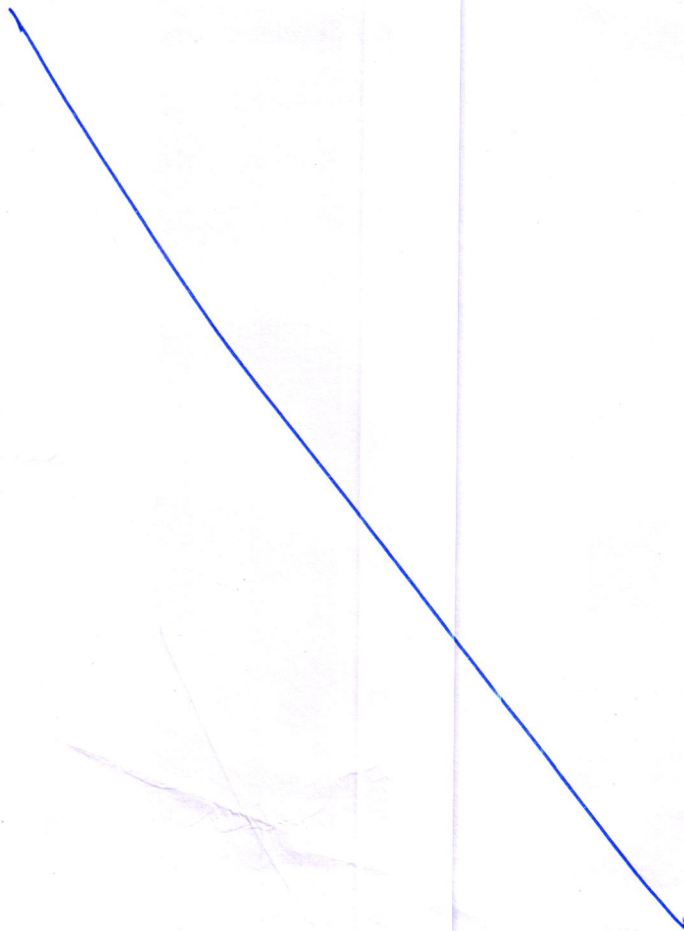

On 24.07.17, the D. C. P. (North Division) was directed to make an enquiry with regard to the custodial death of one female UTP namely Susha Srikumar and to send a report along with copy of judicial enquiry ^{report} if any. The ADG Correctional Services was also directed to submit a detailed report along with copies of P.M report and Magisterial Inquest report.

The aforesaid authorities have not sent any report but the Supt. Dum Dum C. C. H sent a letter ^{on 30.03.18} along with copies of Magisterial Inquest report and P.M. report. No specification of injury is found in the ~~des~~ description of dead body ^{recorded} reflected in Magisterial Inquest report.

It appears from the P.M. report that the death was due to the effect of antemortem diseased condition of heart, lung and liver and further to opinion in reserved till receipt of Chemical Examiner's report.
