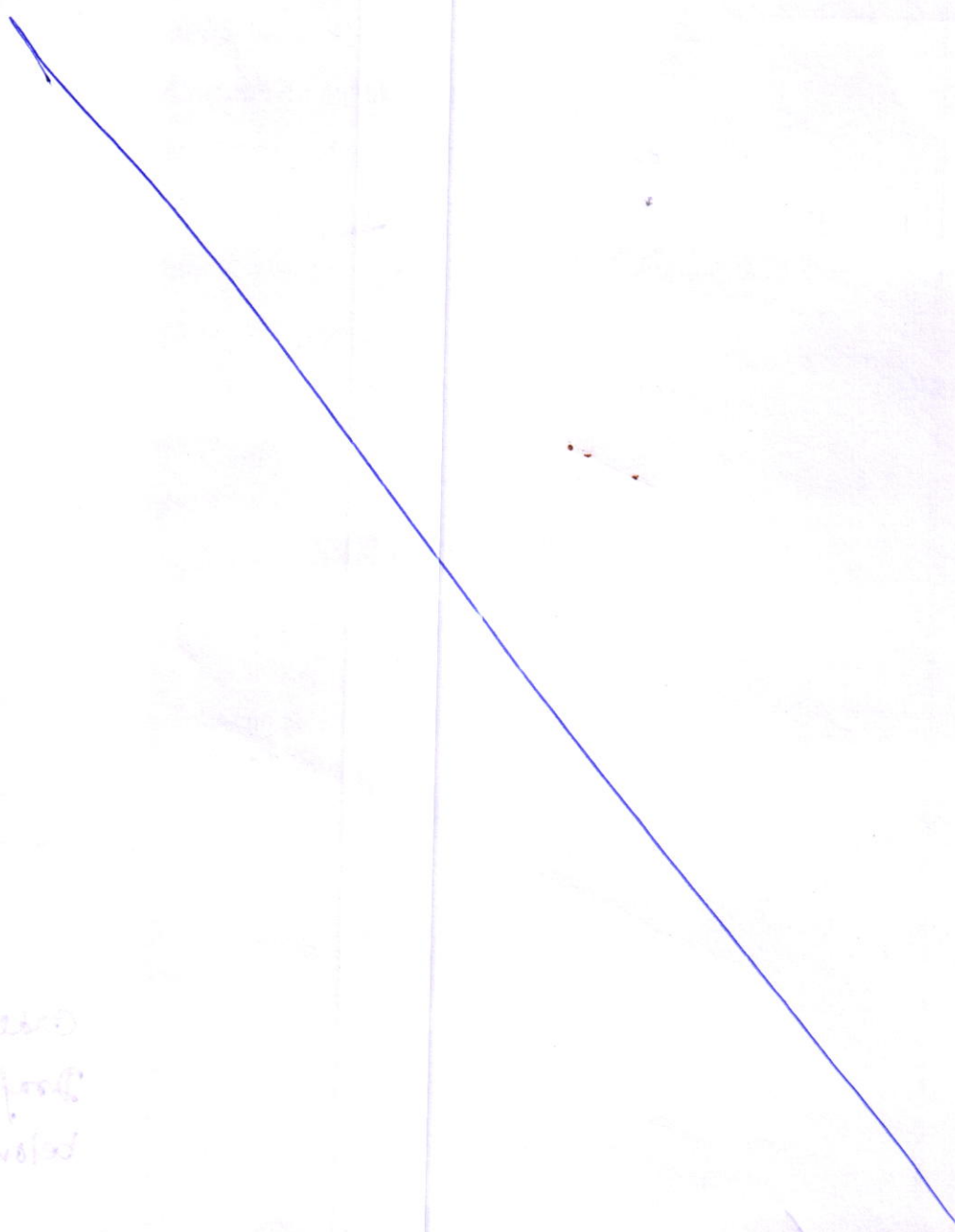

On 17.07.2017 the Dy. Commissioner of Police, North Division was directed to make an enquiry with regard to the custodial death of one life convict namely Pratul Mondal and to submit a report along with copy of judicial enquiry report, if any. The ADG, Correctional Services was also directed to submit a detailed report along with copies of P.M. report and magisterial inquest report.

The aforesaid authorities have not sent any report as yet but the Superintendent, Dum Dum Central Correctional Home has forwarded copy of the communication addressed to SSP, NHRC enclosing the copies of magisterial inquest report and PM report.

It appears that no mark of injury has been specified in the description of the dead body recorded in the magisterial inquest report.

It appears from the P.M. report that the death was due to effects of deceased condition of organs as noted therein and further opinion has reserved till receipt of FSL report.
