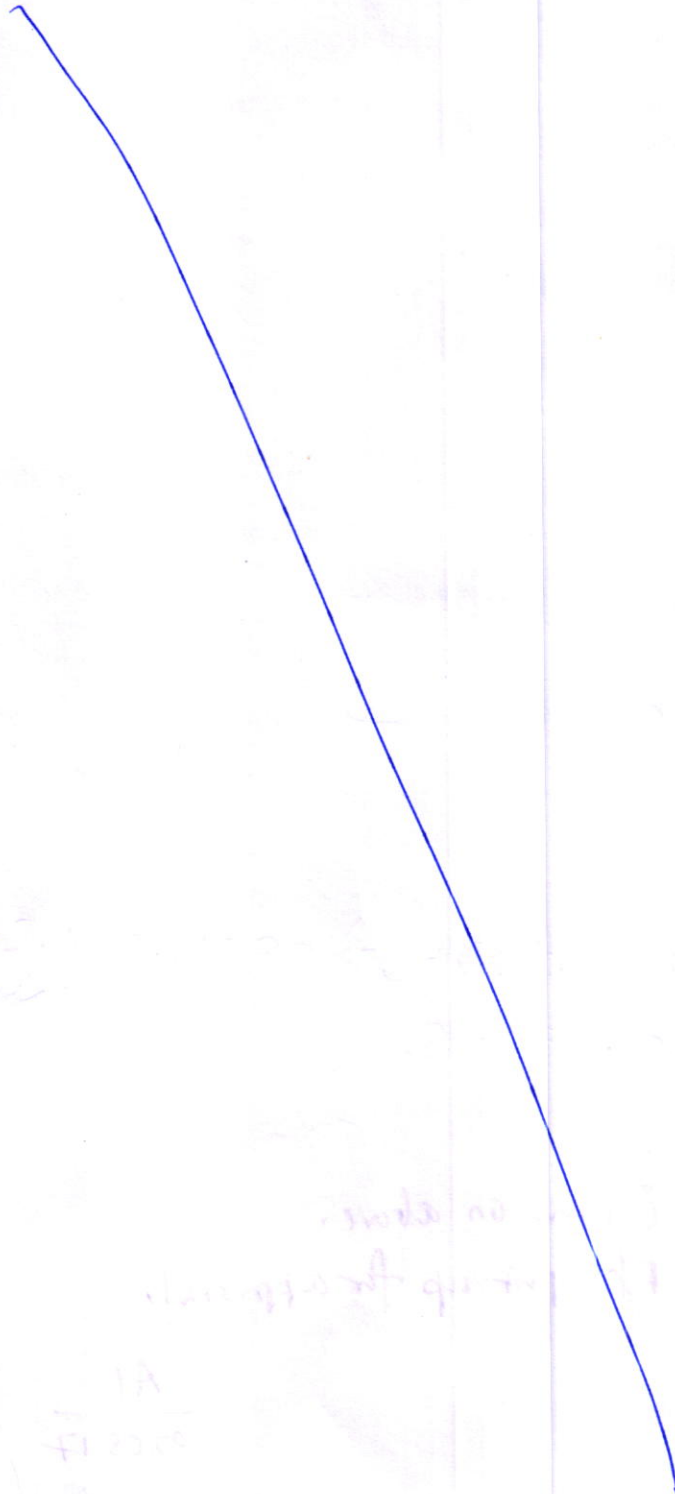

As per Inquest report no marks of external injury was found on his person while examining through naked eyes under ~~the~~ normal day light.
