On 04.09.17 The D.C.P (S.S.D), was directed to make an enquiry with regard to the custodial death of an UTP Sadagar Sk. and to submit a report and also to intimate whether judicial enquiry u/s 176 (1A) (a) of Cr.P.C. was held by the Ld. Judicial Magistrate and to send a copy of the report if such enquiry be done. The D.G. Correctional Services was also directed to submit a report along with <sup>copies</sup> ~~copy~~ of P.M. report and Magisterial Inquest report.

On 21.06.18, the Supdt. Alipore C.C. H. <sup>sent</sup> a copy of the letter addressed to the S.S.P, N.H.R.C and <sup>only</sup> forwarded the ~~two~~ copies of Inquest report and P.M. report but no video cassette / CD of P.M. examination has been forwarded as indicated in the aforesaid letter dated 21.06.18.

The nature of injuries indicated in the Inquest report is as follows.

"One I/N mark on the left elbow. No external marks of injury."

The opinion of the doctor appearing in the P.M. report is as follows:

"Death was due to effects of diseased condition of the organ, as stated above; A natural cause"
