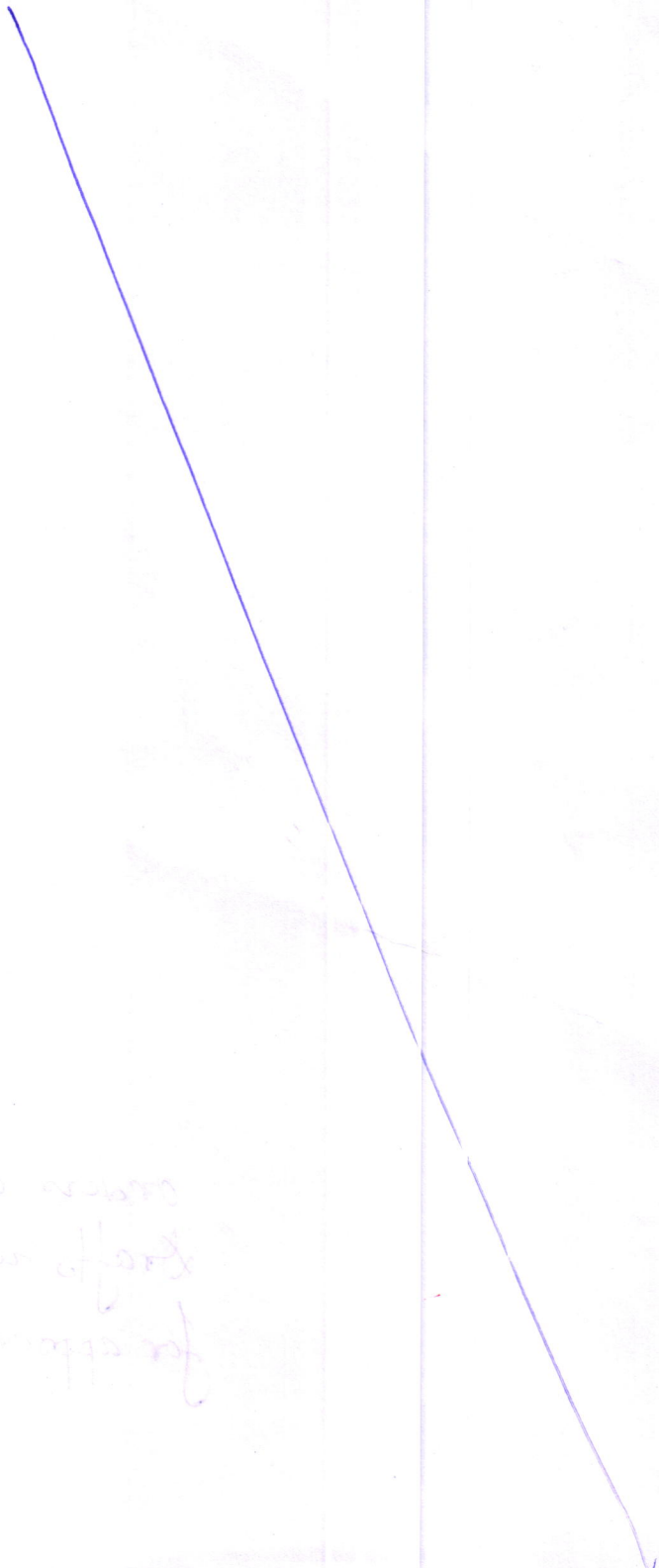

On 12.09.17 this Hon'ble Commission ^{directed} ~~direction~~ the S.P., Howrah (Rural) to cause an enquiry and to submit with regard to the custodial death of one Bivas Mondal who was declared brought dead by the M.O. of Bagnan SHC Hospital and also to intimate whether inquiry by the Judicial Magistrate was done u/s 176(1A)(a) of Cr.P.C. and to send a copy of the report thereof if such inquiry be done.

It appears that the A.D.M. (General), Howrah sent a report dt. 30.11.17 enclosing the copies of Inquest Report, P.M. Report ~~etc.~~ and the inquiry report made by the Executive Magistrate u/s 176 Cr.P.C.

It appears from the copy of the P.M. report that the death was probably due to the effects poisoning (acidic in nature) and the final opinion was referred till receiving of the chemical examiners report. It further appears that by a subsequent report dated 23.04.18 the ADM(General), Howrah sent photocopies of FSL report and final opinion of the doctor. As per FSL report "PHENOL" has been detected in the visera (EXT. A), bottle (Ext.B) and in the torn T-shirt (Ext.C) and the final opinion of the doctor is as follows - "Death was due to the effects of poisoning (Phenol) (acidic in nature) as noted above ante-mortem in nature."
