On 07.09.17, the S.P., Howrah (Rural) was directed to cause an enquiry with regard to the custodial death of an UTP namely Arun Patra and to submit a detailed report and also to intimate whether Judicial Enquiry u/s 176(1A)(a) of Cr.P.C. was held and also to send a copy of report if such enquiry be done. The D.G. Correctional Services was also directed to submit a detailed report along with copies of P.M. report and Magisterial Inquest report.

On 23.05.18, the S.P. Howrah (Rural) forwarded a report along with copies of Magisterial ~~Copy~~ Inquest report and P.M. report as well as a video DVD. It is reported that while his detention at Uluberia Subsidary Correctional Home, the aforesaid UTP was referred to Uluberia SD Hospital for his treatment on 22.08.17 and he expired on the self same date. As per Magisterial Inquest report no ~~any~~ mark of injury was found on the dead body of the aforesaid UTP. The cause and manner of death is stated in the P.M. report as follows:

"Death was probably to the effects of head injury as noted above, ~~at~~ antemortem in nature. However further and final opinion will be given after receiving of CE report (viscera and clotted blood preserved for CE.)"

It is further reported that the judicial enquiry is under process and PSL report is awaited,
