North 24-Parganas at R.G. Kar Medical College & Hospital on 08.10.2017.

The Deputy Commissioner of Police, North Division is directed to make an enquiry and submit report to this Commission within four weeks from the date of communication of this direction. Also intimate whether Judicial enquiry under Section 176 (1A)(a) of Cr.P.C. has been held by Ld. Judicial Magistrate, if so a copy thereof be sent.

DG Correctional Services, West Bengal is directed to submit a detailed report along with copy of Post Mortem and Magisterial Inquest report etc., to this Commission within four weeks from the date of communication of this direction.

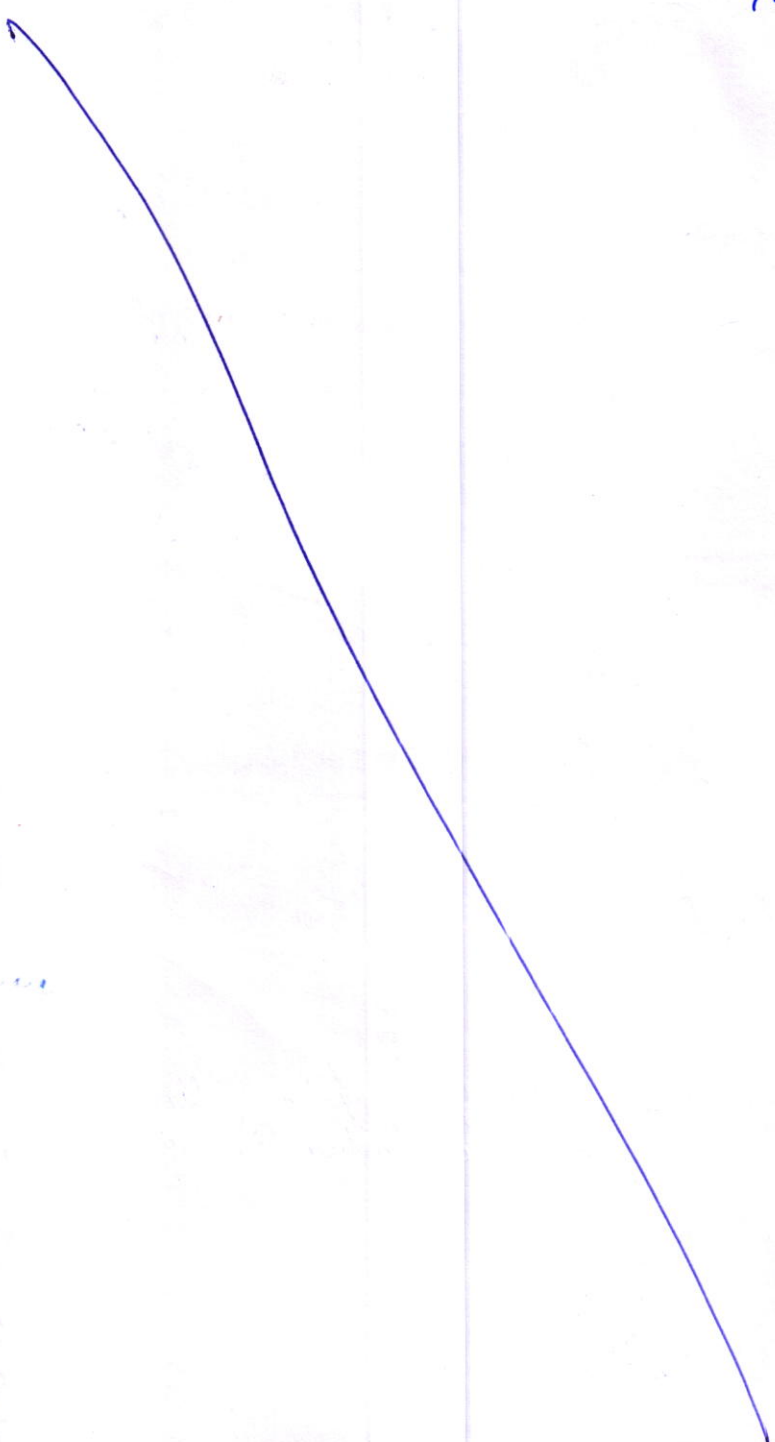

On 12.10.17, the D.C.P. (North Division) and D.G. Correctional Services were directed to send report with regard to the custodial death of one convict namely Ajibar Mirzha. D.C.P. (North Division) was further directed to send a copy of the report of judicial enquiry, if any and D.G. Correctional Services was also directed to send the copy of the Magisterial Enquiry report and P.M. report.

The aforesaid authorities have not complied with the aforesaid order as yet. However WBHR has received the copies of intimation made by the Superintendent Dum Dum Central Correctional Home dated 01.01.18 and 31.01.18.

It appears from the copy of the death certificate enclosed with the letter dated 31.01.18 that the aforesaid convict died at R.G. Kar Medical College & Hospital on 08.10.17. It appears from the copy of the Magisterial Enquiry report that save and except one abrasion mark on the left leg no other mark was found in the dead body of the aforesaid convict. As per P.M. report the death was caused due to the effect of antemortem diseased condition of heart and brain.
