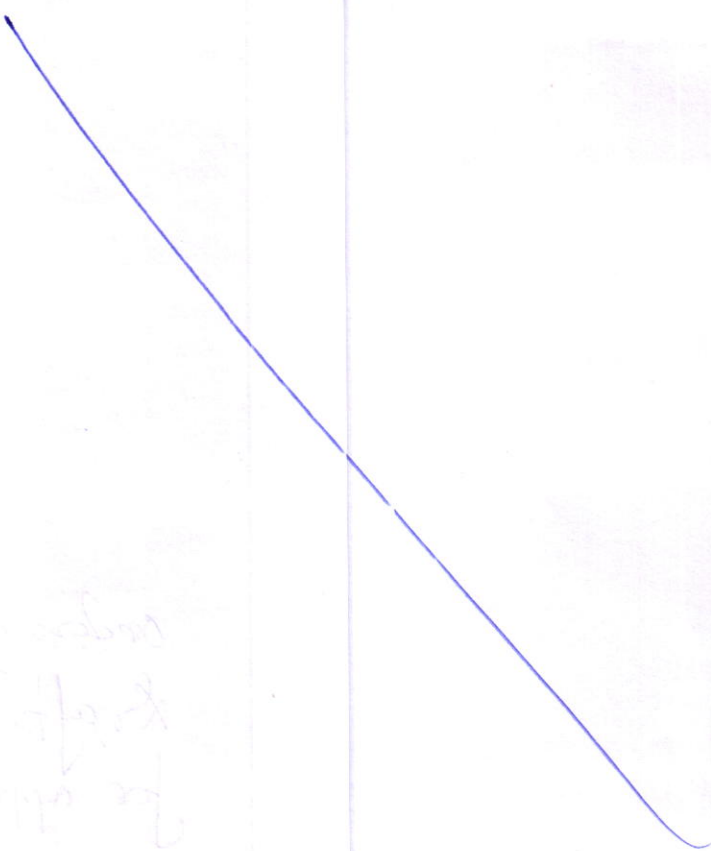

On 19.07.18 D.C.P (S.E.D.) forwarded a report, along with copies of Magisterial Inquest report and P.M. report.

It appears from the copy of the Magisterial Inquest report that no external injury was found on the body of the deceased.

It appears from the copy of the P.M. report that death was due the effects of the diseased conditions, as noted therein ante mortem in nature - a natural cause.

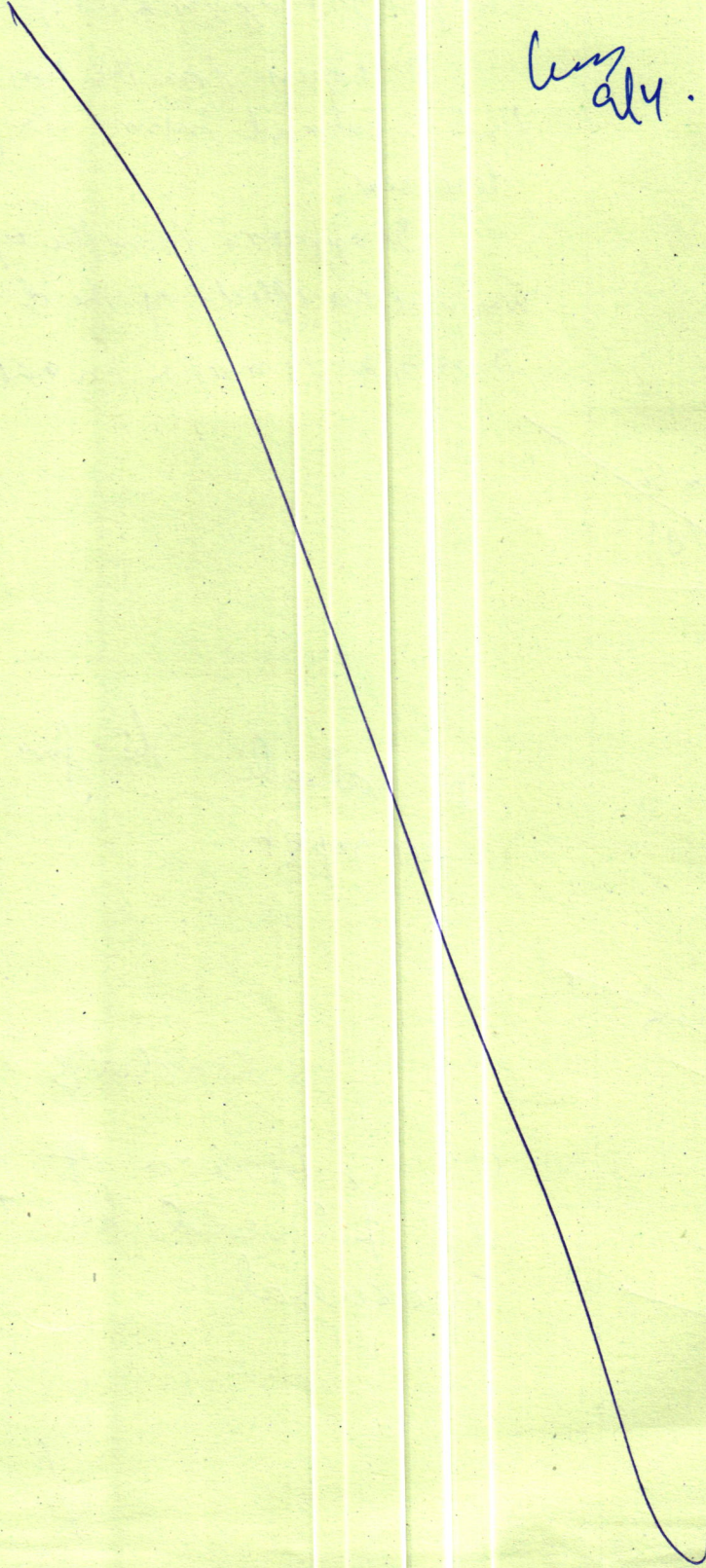
