Also intimate whether Judicial enquiry under Section 176 (1A)(a) of Cr.P.C. has been held by Ld. Judicial Magistrate, if so a copy thereof be sent.

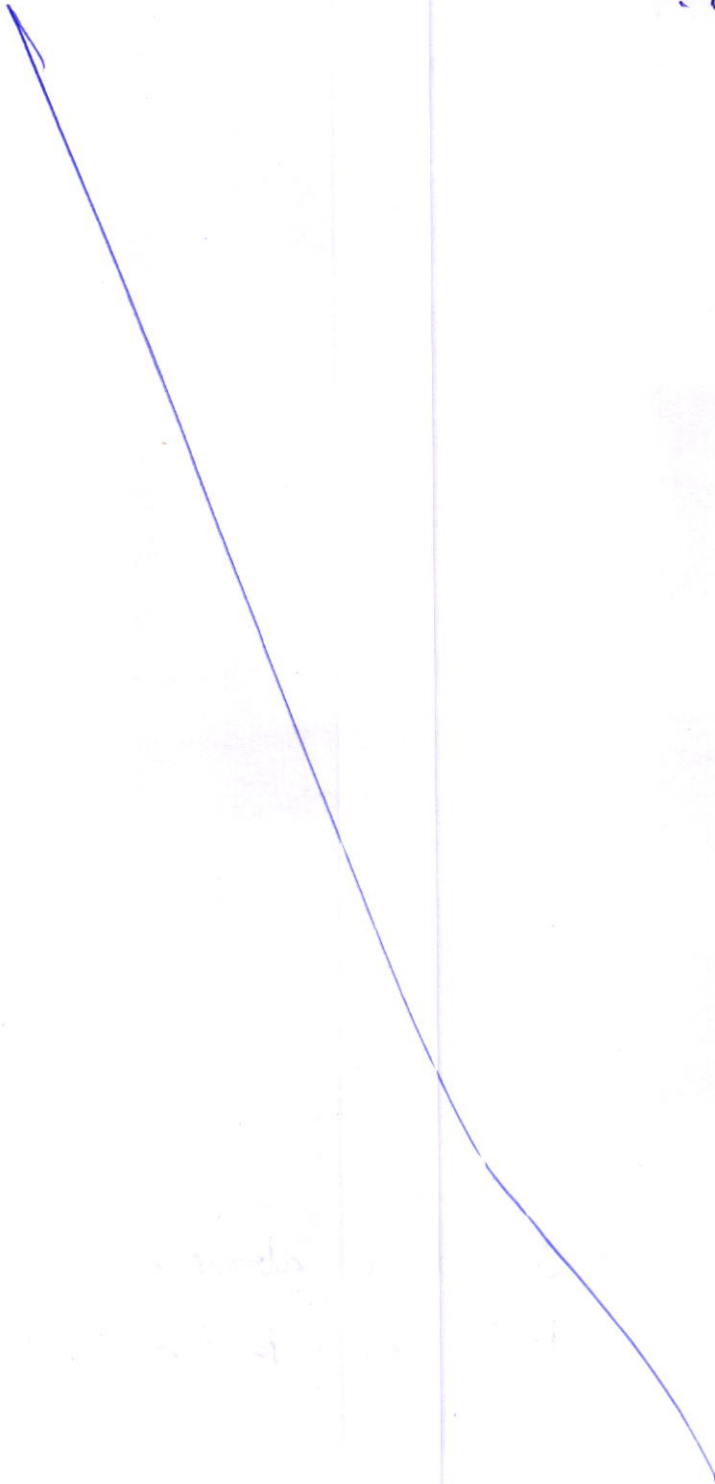

On 02.11.17, the D.C.P (North Division) was directed to make an enquiry with regard to the custodial death of an UTP namely Kushi Nath Halder and to intimate whether judicial enquiry u/s 176(1)(a) of Cr.P.C was held by the Ld. Judicial Magistrate and to send a report thereof if such enquiry ~~was~~ held. The D.C. Correctional Services was also directed to submit a detailed report along with copies of P.M report and Magisterial Inquest reports.

On 07.03.18, the Superintendent, Dum Dum Central Correctional Home sent a letter ~~with~~ enclosing ~~copy~~ copies of Magisterial Inquest report and P.M. report. It appears from the Magisterial Inquest report that save and except ~~an~~ an abrasion mark on the back side of the right knee, ~~there was~~ no external mark of injury was apparently noticed. It appears from the copy of P.M. report that death was due to the diseased condition of lungs as noted - a natural cause.

An intimation was received from Supdt., Dum Dum Central Correctional Home on 16/10/2017 regarding death of UTP, Kushinath Halder at R.G. kar Medical College & Hospital on 14/10/2017. The Commission took cognizance of the matter and directed D.C., North Division as well as D.G., Correctional Services to give detailed report along with copies of post mortem and magisterial inquest reports. According to the inquest report no injuries were found excepting for an external mark of abrasion on back side of right knee. The post mortem report opined that death was due to natural causes, i.e. disease condition of lung. As ^{death} it was occurred due to natural causes the same be filed.
