It is also reported that he was shifted to that Correctional Home from Burdwan Central Correctional Home for better medical facilities.

Also intimate whether Judicial enquiry under Section 176 (1A)(a) of Cr.P.C. has been held by Ld. Judicial Magistrate, if so a copy thereof be sent.

DG, Correctional Services, West Bengal is directed to submit a detailed report along with copy of Post Mortem and Magisterial Inquest report etc., within four weeks from the date of communication of this direction.

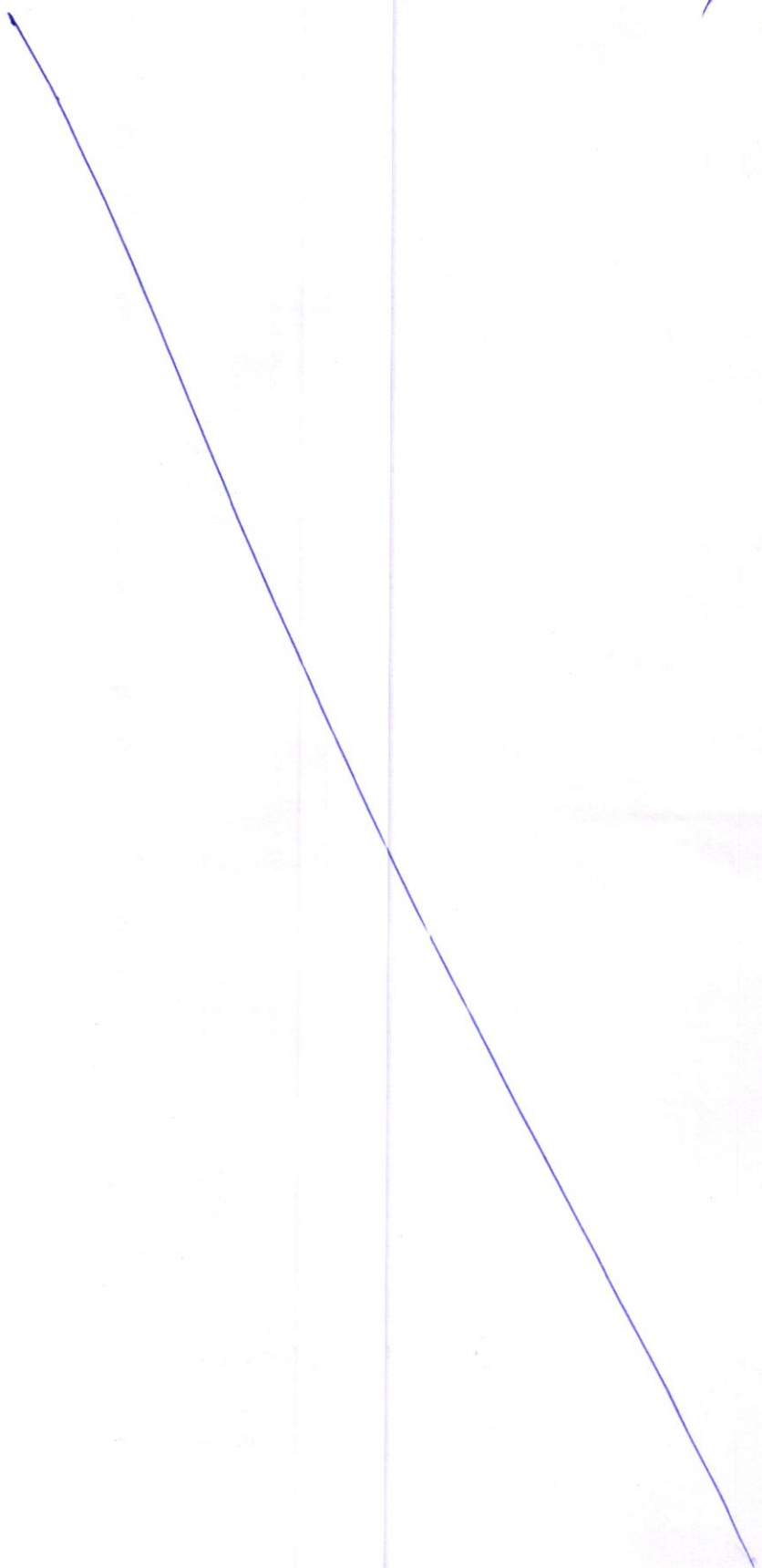

It appears from the copy of the P.M. report that the death was caused due to the effects of diseased condition of organs as noted therein - a natural cause.




It appears from the report of Dr. B. N. Kahali that the opinion about the cause of death can be given in a confirmatory and full-proof manner only on the basis of the FSL report.

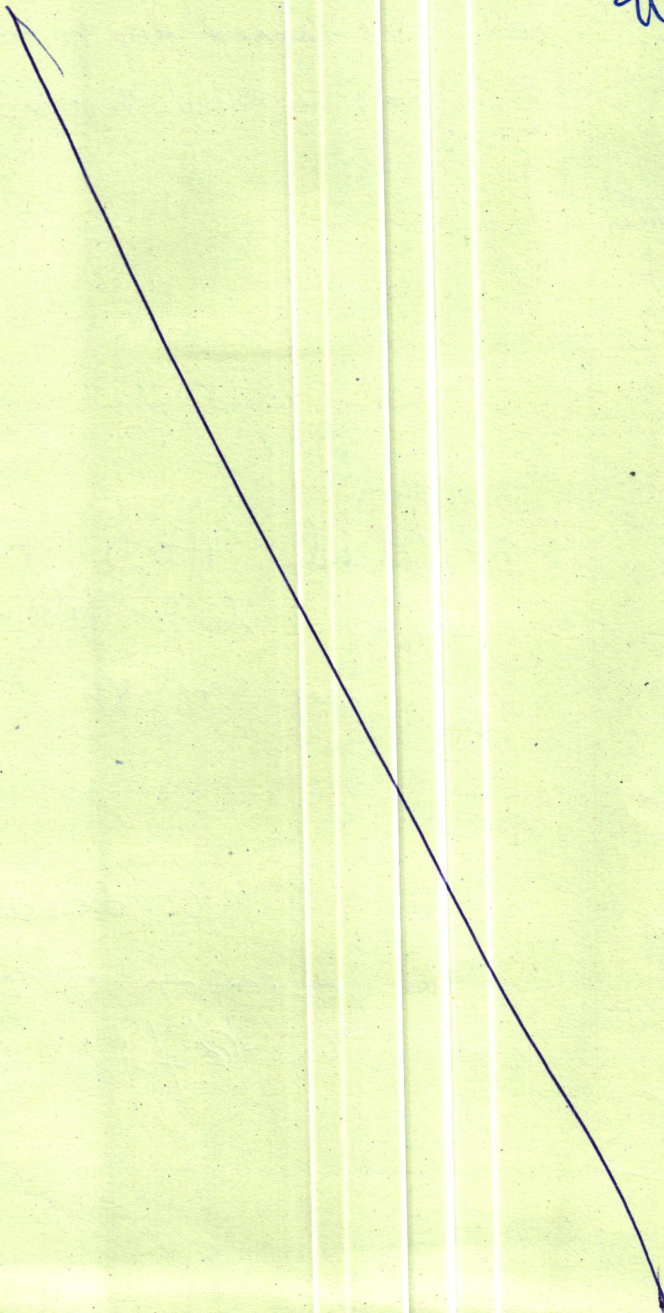
