On 30.01.18, D.C.P (South Division) was directed to make an enquiry with regard to the custodial death of an UTP namely Partha Chatterjee and to submit a report and also to send the copy of the Judicial Enquiry report, if any. D.G. Correctional Services was also directed to submit a detailed report along with copies of P.M. report and Magisterial Inquest report.

The aforesaid authorities have not sent any report as yet but only the copy of the letter of Suptd. Dum Dum Central Correctional Home addressed to the S.S.P, N.H.B.C has been received by WBHRC along with its enclosures being the copies of Magisterial Inquest report, P.M. report and Viscera Examination report.

It appears from the copy of the Magisterial Inquest report that only one I/V mark was found on the left wrist of the body of the deceased.

It appears from the copy of the P.M. report that the death was caused due to ^{effects of} diseased condition of the organs as noted therein but final opinion was reserved till receipt of the Chemical Examiner's report.

It appears from the ^{copy of the} Viscera Examination report that no poison was detected either in the viscera or in the blood of the deceased.
