

On 07.02.18 D.C.P. (South Division) was directed to make an enquiry with regard to the custodial death one convict namely Bndolhadelo Pramanik and to ~~send~~ submit a report and also to send ^{the} Judicial Enquiry report, if any. The D.C. Correctional Services was also directed to submit a detailed report along with copies of P.M. report and Magisterial Inquest report.

On 17.04.18 the Superintendent Presidency Correctional Home sent a report enclosing ^{copies of} Magisterial Inquest report and P.M. report.

It appears from the copy of the Magisterial Inquest report that saliva was there in the ~~mouth~~ left nose of the deceased and there was an abrasion mark on the ~~left~~ left knee points.

It appears from the copy of the P.M. report that death was due to effects of diseased condition involving vital organs as noted therein and further opinion is reserved till receiving of chemical examination report.

On 27.06.18 D.C.P. (South Division) also forwarded a report informing that Magisterial Enquiry was done by empowered Executive Magistrate D.C.T.P. (11) ~~report~~ ^{report} from ^{the} copies of Magisterial Inquest report and ~~P.M.~~ P.M. report, ^{copies of} the Viscera report and Magisterial Enquiry ~~report~~ are enclosed with the said reports forwarded on 27.06.18.

It appears from the copy of the Viscera Examination report that no poison could be detected in the viscera or in the blood of the deceased.

It appears from the copy of the Magisterial Enquiry report that the death was caused due to Illness and there was no ~~custodial~~ custodial violence nor there was any negligence on the part of the custodial authority.
