Also intimate whether Judicial enquiry under Section 176 (1A)(a) of Cr.P.C. has been held by Ld. Judicial Magistrate, if so a copy thereof be sent.

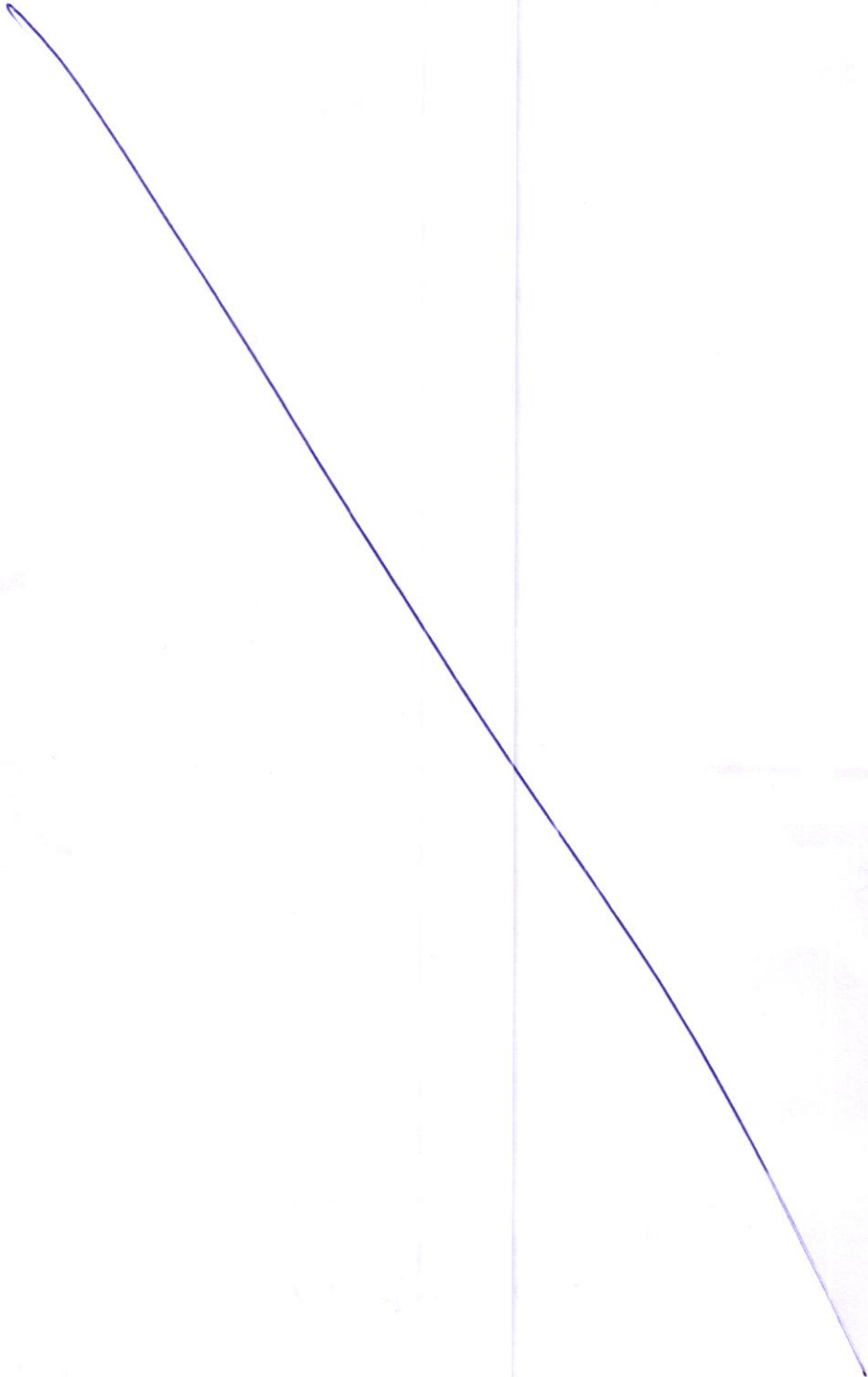

It appears from the copy of Magisterial Inquest report that save and except an abrasion in the left leg, no other external injury was found in the body of the ~~deceased~~ deceased.

It appears from the copy of P.M. report that the death was caused due to the effects of diseased condition as noted therein - a ~~natural~~ natural cause.

It is indicated in the forwarded report that the Viscera report is awaited and the Magisterial Inquiry has been started by the Jd. Municipal Magistrate 5th Court, Sealdah.
