The DG Correctional Services, West Bengal is also directed to submit a detailed report along with copy of Post Mortem and Magisterial Inquest Report within a period of four weeks from the date of communication of this order.

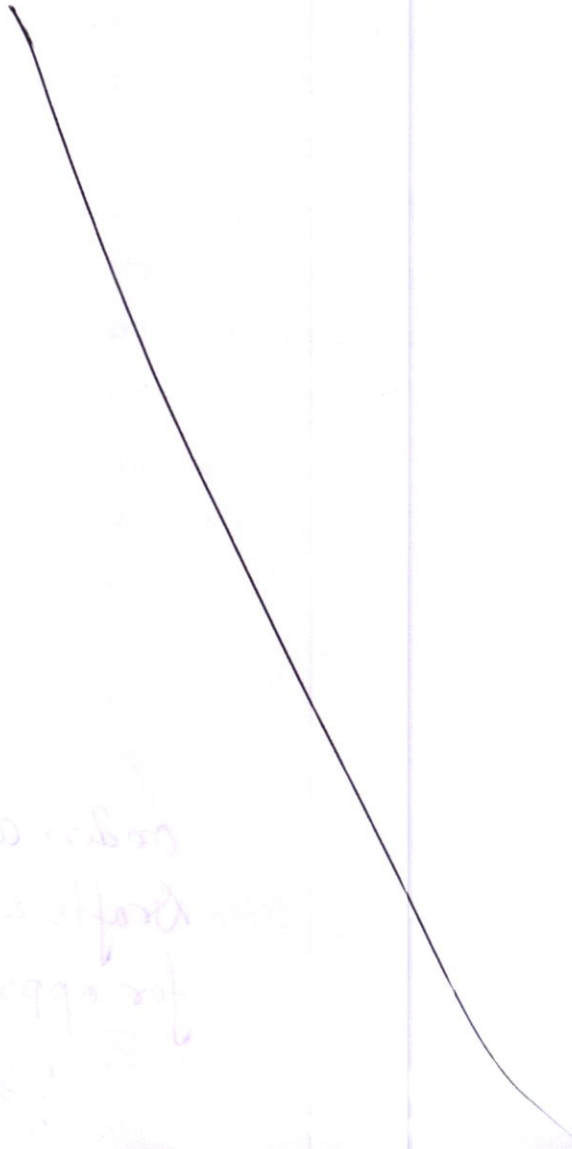

On 12.02.17, the S.P. Murshidabad was directed to cause an enquiry and to submit a report with regard to the custodial death of one Life Convict Prisoner, namely, Hare Ram Mal and to send a copy of the ~~report~~ report of judicial enquiry, if any. The D.G. Correctional Services was also directed to submit a detailed report along with copies of P.M. report and Magisterial Inquest report.

Pursuant to the aforesaid order the S.P. Murshidabad has sent the copies of P.M. report and Magisterial Inquest report.

It appears that no injury mark was found at the time of Magisterial Inquest and P.M. Examination. As per P.M. report, death was due to effects of diseased condition of organs noted therein - a natural cause.

It is reported that the Viscera ~~Ex~~ Examination report is kept pending but it has not been reported as to whether judicial enquiry has been done or not.

Information was received from Supdt., Berhampore Central Correctional Home regarding custodial death of life convict, Hare Ram Mal ^(65 year) on 27/1/2018 at Murshidabad Medical College and Hospital. Reports were called from S.P., Murshidabad regarding post mortem, inquest etc. The post mortem report indicated that death was due to natural causes/disease condition of organs. The magisterial inquest report did not show any injuries. Although, the viscera has been sent FSL for examination yet I am of the view that this will serve no additional purpose since the post mortem report has clearly indicated the cause of death. In view of above the matter be filed.
