Also intimate whether Judicial enquiry under Section 176 (1A)(a) of Cr.P.C. has been held by Ld. Judicial Magistrate, if so a copy thereof be sent.



On 23.02.18, D.C.P (North Division). was directed to make an enquiry with regard to the custodial death of one ~~innocent~~ female UTP Sima Das (Mondal) and to submit a report and also to intimate whether judicial enquiry u/s 176(1A)(a) Cr.P.C. had been held by Ld. Judicial Magistrate and to send a copy of the enquiry report if such enquiry be held. The D. G. Correctional services was also directed to submit a detailed report along with P.M. report and Magisterial Inquiry report.

On 27.06.18 D.C.P (North ~~Division~~ North Suburban Division), Kolkata forwarded a report along with attested copies of P.M report and Inquest report.

It appears from the copy of P.M report that the opinion of the doctor is as follows:

"Death was due to septic shock resulting from antemortem diseased condition of lungs, liver and kidney as noted above - ~~as~~ a natural cause".

The copy of the Inquest report is not legible. It has been further reported that the video cassette of P.M. examination has already been sent to the ~~Sd~~ Superintendent ~~at~~ Dum Dum Central Correctional Home. It has also been informed that viscera has not been preserved. It has further been informed that the Magisterial Inquiry was done by the Ld. J.M. 5th Court, Sealdah and the report is lying at that Ld. Court.

The communication dated 11.07.18 is nothing but the copy of the letter sent by Supdt. D.D.C.H. to the S.S.S.P NHRC.

An intimation was received from Supdt., Dum Dum Central Correctional Home intimating custodial death of a female UTP, namely, Sima Das (27 years) at R.G. Kar Medical College & Hospital on 10/2/18. The UTP was detained at DumDum Central Correctional Home in connection with Bongaon P.S. Case No.1154 dt.04/12/17 u/s 379/411/413/414/34 IPC and II of P.C. to Animal Act, 1962 on orders of Ld. ACJM, Bongaon. She transferred from Bongaon Correctional Home on 07/1/18. The female UTP referred to R.G. Kar Medical College and Hospital on health ground for better treatment on 16/1/18. She expired on 10/2/18. Ld. Registrar is directed to take following actions :

- i. immediately obtain a copy of Judicial Magistrate enquiry conducted by Ld. J.M., 5<sup>th</sup> Court, Sealdah if required through Ld. Court.
- ii. Obtain a legible copy of inquest report.
- iii. Dr. Kahali, HOD, FSM, SSKM Hospital and our in-house expert to examine the P.M. report and give his comments.
