



Central Correctional Home at 4.5.18 reveals

that life convict Ma Ladeb Dutta
was admitted at Central Correctional Home
on 2-9-2007 and he committed suicide by
hanging himself with a garbeta from his neck
at Room no 24 32 of the cell (block). As per
statement of Medical Officer of Correctional Home
the life convict was suffering from psychiatric
illness and was getting treatment regularly.
He committed suicide on 1/02-3-2018 at 12.20
AM. His body was duly post mortumed
and handed over to his father Titu Dutta
after post mortum. The magisterial enquiry
report could not be submitted due to non receipt
of the same. The Visore report is also waiting.

B.N. Karali dt 15.2.19 submits
that the cause of death of deceased
Motilal Dutta 40 yrs. Male Hindu
was due to effect of hanging, ante
mortem in nature further opinion will be
given after receiving CFS report. There
is no evidence of torture or
injury on the body of the deceased.
The hanging is anti mortem in
nature can be opined from 1) Charistic
ligature mark 2) Drilling of the Saliva
from mouth and frostic. Final
& confirmed opinion can be given after
perusing Histopathological & FSL report.
