DG, Correctional Services, West Bengal is directed to submit a detailed report along with copy of Post Mortem and Magisterial Inquest report etc., within four weeks from the date of communication of this direction.

Am. His body was duly post mortemmed
and handed over to his father Titen Dutta
after post mortem. The magisterial enquiry
report could not be submitted due to non receipt
of the same. The Visum Report is also waiting.

that the cause of death of deceased
Motadar Dutta 40 yrs Male Hindu
was due to effect of hanging, ante
mortem in nature further opinion will be
given after receiving CE's report. There
is no evidence of fracture or
injury on the body of the deceased.
The hanging is ante mortem in
nature can be opined from 1) Characteristic
ligature mark 2) Drilling of the saliva
from mouth and proctric. Final
& confirmed opinion can be given after
perusal of histopathological & FSL report.
