Raniya Paschimpara, Raniya Gobindapur, PS- Nodakhali, Dist. South 24-Parganas at C.N.M.C Hospital, Kolkata on 11. 03. 2018 at about 04:45 P.M. It is also reported that he was shifted to that hospital from M.R. Bangur Hospital for better medical treatment.





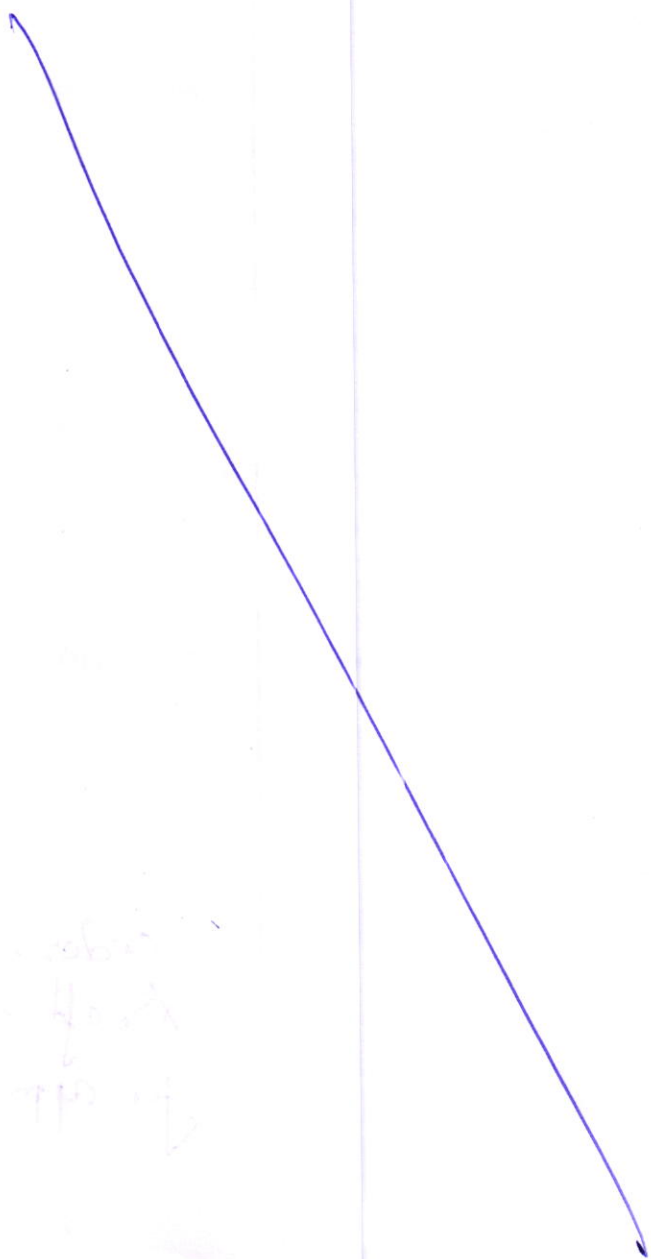

It appears from the Magisterial Inquest report
that no external mark of injury was noticed except
some wounds on the backside like bed sore.

It appears from the P.M. report that death is
suggestive of due to the pathological condition
of organs as noted therein, a natural cause.

It has been further reported that the Visera
Examination report and the Judicial Enquiry report
will be submitted after collecting the same.
