A Radiogram Message vide Memo No. 3227/AB-II dated 14.04.2018 has been received from the Superintendent, Presidency Correctional Home, intimating custodial death of one UTP, namely, Sabid Ali Laskar, aged about 30 years, son of Late Fakir Laskar of Bahirbena, PS-Canning, Dist. South 24-Parganas who committed suicide by hanging himself from the grill of the unused canteen building of the said Home on 14.04. 2018 at about 04:50 P.M.

The Dy. Commissioner of Police, South Division is directed to make an enquiry and to submit his report to this Commission within four weeks from the date of communication of this direction. Also intimate whether Judicial enquiry under Section 176 (1A)(a) of Cr.P.C. has been held by Ld. Judicial Magistrate, if so a copy thereof be sent.

DG, Correctional Services, West Bengal is directed to submit a detailed report along with Post Mortem and Magisterial Inquest report etc., to this Commission within four weeks from the date of communication of this direction.

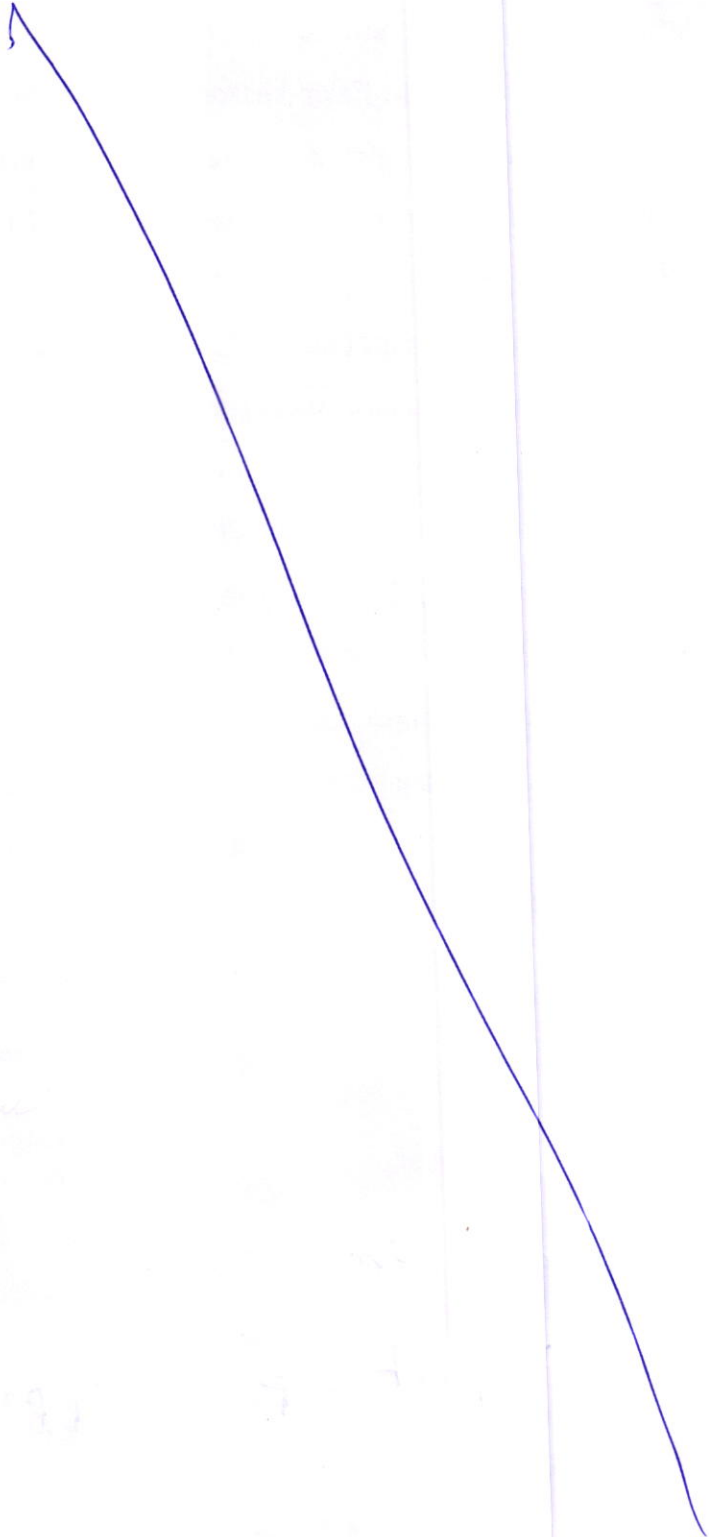

However WBHR has received only the copy of the letter dated 09.07.18 forwarded by ^{the} Supt. Prisoner Correctional Home addressed to the S.S.P., N.H.R.C. with the copies of Magisterial Inquest report and P.M. report.

It appears from the copy of the Magisterial Inquest report that some blood was found in the right ear of the dead body and non-continuous deep ligature mark around the neck having gaps on left upper neck was also found but the nature of injury written in serial no. (3) is not at all legible.

It appears from the copy of P.M. report that the death was due to the effects of antemortem hanging, as noted therein and further opinion is reserved till the receipt of chemical examiner's report.
