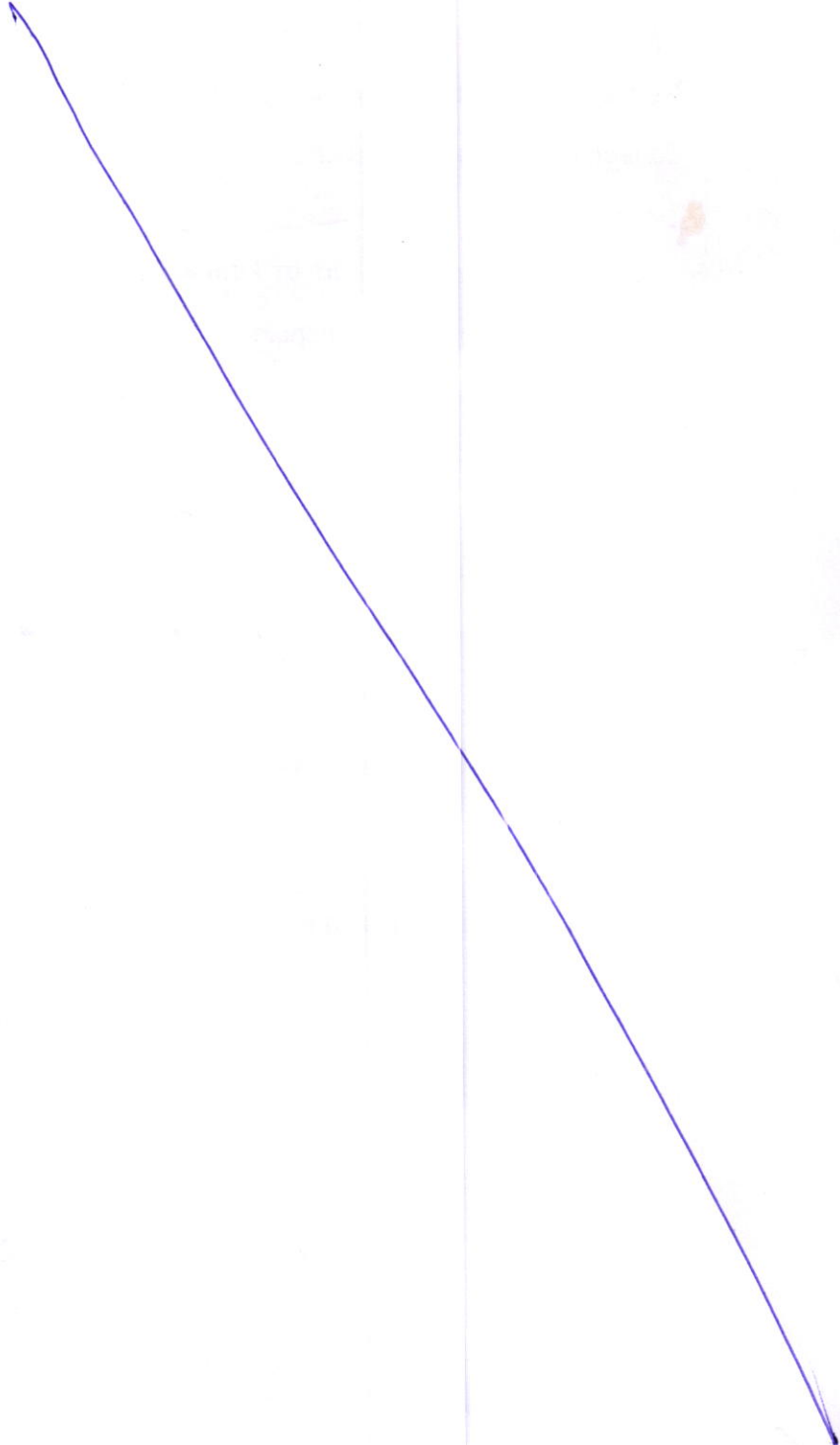

It appears from the certified copy of the Magisterial Inquest report that there was no spot of beating or bruise and no ^{spot of} mechanical injury was identified.

It appears from the certified copy of the P.M. report that death was due to diseased condition of heart as noted herein - a natural cause.

As per the aforesaid report the article kept in the sealed envelope in the video cassette of P.M. examination. It is also reported that the PSL report is still awaited and the Magisterial Enquiry has not been done as yet.
