





D.G. Correctional Services, West Bengal is directed to submit a detailed report along with copy of Post Mortem and Magisterial Inquest Report etc., to this Commission within four weeks from the date of communication of this direction.

However it appears from the photocopy of the Magis-  
terial inquest report that no external mark of injury could  
be seen apparently in the body of the deceased.

It appears from the P.M. report that <sup>opinion as to</sup> cause of  
death has been kept pending till receiving of the chemical, histo-  
pathological and microbiological report.

It further appears that. Visum Examination report  
is still now not available. Thus the question of final opinion  
does not arise at all at this stage.
