D.G. Correctional Services, West Bengal is directed to submit a detailed report along with copy of Post Mortem and Magisterial Inquest Report etc., to this Commission within four weeks from the date of communication of this direction.

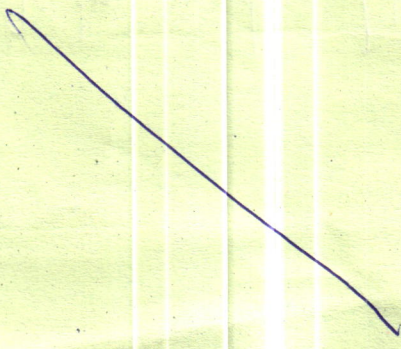


On 25.06.2018 the Hon'ble Commission took cognizance on an intimation of custodial death of UTP Madhab Karmakar and the DCP, North Division was directed to make an enquiry and to submit a report and also to intimate as to whether the judicial enquiry was done in this matter or not. The D.G., Correctional Services was also directed to submit a detailed report along with copies of post-mortem report and magisterial inquest report.

Pursuant to the aforesaid order, DCP, North and North Suburban Division has submitted a report along with copies of post-mortem report and magisterial enquiry report.

It appears from the copy of magisterial enquiry report that 'save and except and some abrasion marks and swelling, no injury mark was found in the dead body and as per post-mortem report death was due to the effects of diseased conditions and organs as noted therein and further opinion was reserved for FSL report.

It further appears that A.S.(C) has already made a note in NSP-2 with regard to the order passed by NHRC in this matter. The downloaded copy of the said order is also tagged ^{with} to the file. It appears that after considering all the relevant reports the case has already been disposed of by NHRC.
