Of Police, Nadia intimating custodial death of one Robin Roy son of Late Hiralal Roy of Barasat Taldangapara (East), P.S.Taherpur, Dist-Nadia who was arrested in connection with Taherpur P.S. Case No.147/18 dated 18.07.2018 u/s 376 I.P.C. and u/s 6 of the POCSO Act and on 19.07.2018 during his medical check up before production in the Court of the Ld. A.C.J.M., Ranaghat he was found ill and on 20.07.2018 he was referred to Saktnagar District Hospital under P.S. Krishnanagar, Dist-Nadia and on 22/07/2018 he was found in hanging condition at 02.55 hours inside the bathroom of the said hospital.

The Supdt. Of Police, Nadia is directed to cause an enquiry and to submit a report to this Commission within four weeks from the date of communication of this order along with the copy of post mortem report and Magisterial Enquiry Report and to intimate as to whether inquiry by the Judicial Magistrate has been done u/s 176(1A)(a) Cr.P.C. along with copy of report thereof if such inquiry is done.

The Chief Medical Officer, Health is also directed to submit a detailed report within four weeks from the date of communication of this order.

This direction is to be communicated forthwith.
