




Superintendent of Police, Murshidabad is directed to enquire into the matter and submit a detailed report along with the copy of post-mortem report and the copy of Magisterial inquest report within 4(four) weeks from the date of the communication of this order and to intimate whether enquiry by Judicial Magistrate has been done under Section 176(1A)(a) of Cr.P.C. If so, a copy of the report thereof be sent to the Commission.

D.G. Correctional Services, West Bengal is directed to submit a detailed report along with copy of Post Mortem and Magisterial Inquest Report etc., to this Commission within four weeks from the date of communication of this direction.

On 31.07.18, S.P. Murshidabad and D.G. Correctional Services
were directed to submit their respective reports with regard to
the custodial death of one U.T. Prisoner Mijanul Sh along
with specific information/documents.

The aforesaid authorities have not submitted any report till
now but the District Judge Murshidabad has forwarded the judicial
enquiry report made by the Ld. J.M. 3rd Court Berhampore.

It appears from the said report that the same ^{has} ~~was~~ ^{been} prepared
after examining as many as 12 witnesses including the Superintendent
of the Correctional Home concerned, the doctor who ~~was~~ was called for
the treatment, the Executive Magistrate who conducted inquest, several
co-inmates and also the doctor who conducted P.M. examination.
The report has been concluded by stating that the aforesaid O.T.P.
died due to his ailments and there was no case of any torture
during the judicial custody.
