Biswanath Das of Vill-Lalkuthipara, P.S.Suri, Dist Birbhum, who was declared brought dead by the Medical Officer of Burdwan Medical College & Hospital on 10.12.2019 at about 03.00 hrs.

The Superintendent of Police, Purba Bardhaman is directed to cause an enquiry and to submit a report within four weeks from the date of communication of this order and to intimate whether enquiry by Judicial Magistrate has been done under section 176(1-A)(a) of Cr.P.C. In case it has been done a legible copy be sent. In case it has not been done, the reason therefor should be informed.

DG, Correctional Services, West Bengal is directed to submit a detailed report along with copy of Post Mortem report and Magisterial enquiry report etc. within four weeks from the date of communication of this direction.

This direction is to be communicated forthwith.




