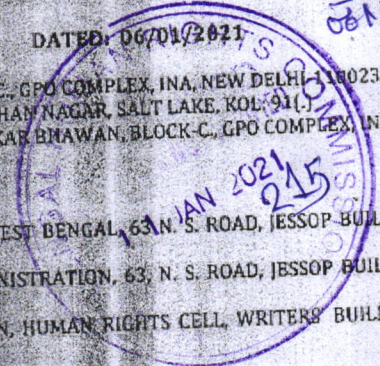

SINTHI, KOLKATA-02, EXPIRED ON 06/01/2021 EVENING AS INFORMED BY OUR ON DUTY STAFF WHILE ADMITTED AT CALCUTTA NATIONAL MEDICAL COLLEGE HOSPITAL (.) THE SAID CONVICT WAS COMMITTED AT THIS CORRECTIONAL HOME ON 21/12/2018, AS CONVICTED BY THE LD. COURT OF ADDL. DISTRICT & SESSIONS JUDGE, 7TH FAST TRACK COURT, ALIPORE, 24 PARGANAS (SOUTH), IN C/W ST. CASE NO-13(11)2008, SC-131(9)2008 (ARISING OUT OF GARIHAT PS CASE NO-101/2008, U/S- 392/411/34 IPC, FOR SERVING R.I FOR 07 (SEVEN) YEARS WITH FINE OF RS.10,000/- I.D TO SUFFER FURTHER R.I FOR 03 (THREE) MONTHS AND TO SUFFER FURTHER R.I FOR 03 (THREE) YEARS WITH FINE OF RS.5000/- I.D TO R.I FOR 01 (ONE) MONTH WHERE ALL SENTENCES WERE TO RUN CONCURRENTLY ON 21.12.2018 (.)

ON 03-10-2020 THE SAID CONVICT WAS SENT TO SSKM HOSPITAL AS A LIFE SAVING MEASURE WITH COMPLAINT OF ABDOMINAL PAIN BUT RETURNED ON THE SAME DAY AFTER NECESSARY TREATMENT AND MEDICATION (.) ON 08.10.2020 HE WAS ADMITTED AT C.N.M.C HOSPITAL FOR TREATING ASCITIS AND CHRONIC LIVER DISEASE AND WAS DISCHARGED ON 16.10.2020 (.) ON 26.11.2020 HE WAS SENT TO MEDICINE OPD AT CNMC HOSPITAL FOR FOLLOW UP TREATMENT AND LATER ON 24.12.2020, (.) THE I/C SINTHI POLICE STATION IS REQUESTED TO INFORM THE MESSAGE TO HIS NEAR RELATIVES AND REQUEST THEM TO REMAIN PRESENT DURING MAGESTERIAL INQUEST, POST MORTEM EXAMINATION AND TO TAKE CHARGE OF THE DEAD BODY ON COMPLETION OF ALL LEGAL PROCEDURES (.) THE I/C HASTINGS PS IS REQUESTED TO LODGE AN U.D. CASE IN CONNECTION WITH THE CUSTODIAL DEATH OF THE SAID CONVICT AND TO MAKE IMMEDIATE ARRANGEMENT FOR MAGISTRIAL INQUEST AND POST-MORTEM EXAMINATION ON THE DEAD BODY UNDER VIDEOGRAPHY AND TAKE OVER THE CHARGE ON THE DEAD BODY OF THE CONVICT AND ALSO REQUESTED TO MAKE OVER THE CHARGE TO THE NEAR RELATIVES ON COMPLETION OF ALL OFFICIAL PROCEDURES AS PER RULE.
