P.C. which is mandatory in view of the order dated 04.09.2020 passed by NHRC.

The Director General of Correctional Services, West Bengal is also directed to submit a detailed report alongwith copy of Post Mortem report and Magisterial Inquest report etc. by 02.03.2021.

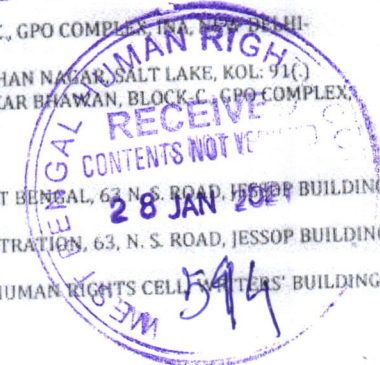

BY THE ON-DUTY M.O OF S.S.K.M HOSPITAL, AS INFORMED BY OUR ON DUTY STAFF, WHILE GOING TO ADMIT AT THE SAID HOSPITAL ()

THE SAID CONVICT WAS RECEIVED ON TRANSFER FROM BERHAMPORE CENTRAL CORRECTIONAL HOME ON 16/01/2021 FOR BETTER MEDICAL TREATMENT AND MANAGEMENT() THE SAID DECEASED WAS CONVICTED BY THE LD. COURT OF ADDL. SESSIONS JUDGE, 2ND FAST TRACK COURT, BERHAMPORE, MURSHIDABAD, ON 29.01.2014 IN C/W SSL NO-561/04, (ARISING OUT OF DOMKAL PS CASE NO-18/2004, U/S- 307/302/120B/34 IPC, FOR SERVING R.I FOR 10 (TEN) YEARS WITH FINE OF RS.2,000/- LD TO SUFFER FURTHER R.I FOR 06 (SIX) MONTHS AND TO SUFFER FURTHER R.I FOR LIFE WITH FINE OF RS.5,000/- LD TO R.I FOR 02 (TWO) YEARS AND R.I FOR 10 (TEN) YEARS WITH FINE OF RS.2,000/- LD TO R.I FOR 06 (SIX) MONTHS, WHERE ALL SENTENCES WERE TO RUN CONCURRENTLY ()

TODAY ON 23.01.2021, THE SAID CONVICT WAS SENT TO SSKM HOSPITAL ON LIFE SAVING MEASURE AS THE CLINICAL CONDITION OF HIM WAS DETERIORATED BUT ON ARRIVAL AT THE SAID HOSPITAL HE WAS DECLARED BROUGHT DEAD()
