P.C. which is mandatory in view of the order dated 04.09.2020 passed by NHRC.

The Director General of Correctional Services, West Bengal is also directed to submit a detailed report alongwith copy of Post Mortem report and Magisterial Inquest report etc. by 15.02.2021.
