The Superintendent of Police, Murshidabad is directed to cause an enquiry and to submit a report by 30.04.2021 positively along with the enquiry report made by the Judicial Magistrate under section 176(1A) of the Cr. P.C. which is mandatory in view of the order dated 04.09.2020 passed by NHRC.

The Director General of Correctional Services, West Bengal is also directed to submit a detailed report alongwith copy of Post Mortem report and Magisterial Inquest report etc. by 30.04.2021.

This direction is to be communicated forthwith.

With due respect, I beg to report that one letter from Superintendent of Kandi Sub-Divisional Correctional Home was received today (21.02.2021) at 16:40 hrs. in which he stated that one UTP namely Ananda Gopal Guin (36) S/O Lt. Bahindra Nath Guin of Vill- Shirpara, PS- Salar, Dist- Murshidabad in c/w Salar PS Case No. 229/2020 dt 03.12.2020 U/S 302/326/307 IPC, GR- 1704/2020 by the Ld. ACJM Kandi committed suicide hanging himself by tightening a 'gamchha' in his neck inside of Kandi Subsidiary Correctional Home (.)

Subsequently, as per requisition to the Superintendent of Kandi SD Hospital by Superintendent of Kandi Subsidiary Correctional Home, the attending medical officer checked him and thereafter the said UTP was brought to Emergency Section of Kandi SD Hospital where the attending doctor declared him as brought dead (.)

Over this incident a UD Case vide Kandi PS UD Case No. 23 dt. 21.02.2021 has been registered at this P.S., SI Bhanjn Biswas has been endorsed to investigate the case (.)

SI Bhanjan Biswas prepared the Surathal report over the dead body of the deceased and already submitted a prayer before SDO Kandi Sub-Division for deputing an Executive Magistrate for holding Magisterial Inquest over the dead body of the deceased and Post Mortem Examination is to be done under proper videography as per guideline of NHRC (.)

An intimation letter has also been sent to the relative of the deceased through O/C, Salar PS, Murshidabad PD for informing the matter to remain present at the time of Post Mortem Examination (.)
