The Director General of Correctional Services, West Bengal is also directed to submit a detailed report alongwith copy of Post Mortem report and Magisterial Inquest report etc. by 30.04.2021.

BASANTA KUMAR MALI, OF VILL-CHUPRI GHARA, P.S-KULTALI, 24 PARAGANAS (S), EXPIRED ON 16.02.2021 AFTERNOON AS INFORMED BY OUR ON DUTY STAFF. WHILE ADMITTED AT SSKM HOSPITAL (.)** THE SAID CONVICT WAS RECEIVED FROM BARUIPUR CENTRAL CORRECTIONAL HOME ON 29.01.2021 FOR BETTER MEDICAL TREATMENT. THE SAID CONVICT WAS CONVICTED BY THE LD. JUDGE SPECIAL COURT, EC ACT & ADDITIONAL DISTRICT JUDGE, ALIPORE, 24 PARAGANAS(S) R.I. FOR LIFE IN CONNECTION WITH KULTALI P.S. CASE NO. 4(1)/85 DTD. 16.01.1985, ST NO. 3(5)/93, SC. 13(3)/92, U/S 302, 148/149 IPC(.

THE SAID CONVICT WAS SUFFERING FROM CHEST PAIN, DIABETIC & PSVT WHEN RECEIVED FROM BARUIPUR CENTRAL CORRECTIONAL HOME. THE SAID CONVICT WAS SENT TO SSKM HOSPITAL AS A LIFE SAVING MEASURE ON 29.01.2021. HE WAS DISCHARGED FROM THERE ON 10.02.2021 AND RETURNED INSIDE HOSPITAL NO.5. WHERE HE WAS FOLLOWED THE MEDICATIONS AS PRESCRIBED BY SSKM HOSPITAL (.) ON 15.02.2021, AS HIS CLINICAL CONDITION FURTHER DETERIORATED THE SAID PATIENT INMATE WAS ADMITTED TO SSKM HOSPITAL AS A LIFE SAVING MEASURE AND WAS UNDER TREATMENT THERE SINCE THEN (.)

RECEIVED INFORMATION OVER TELEPHONIC MESSAGE AT ABOUT 13:15 HRS ON 16.02.2021 FROM THE ONDUTY GUARDING STAFF DETAILED AT SSKM HOSPITAL ON THE SAID CONVICT REGARDING HIS DEATH (.) THE I/C KULTALI POLICE STATION IS REQUESTED TO INFORM THE MESSAGE TO HIS NEAR RELATIVES AND REQUEST THEM TO REMAIN PRESENT DURING MAGESTERIAL INQUEST , POST MORTEM EXAMINATION AND TO TAKE CHARGE OF THE DEAD BODY ON COMPLETION OF ALL LEGAL PROCEDURES (.) THE I/C HASTINGS PS IS REQUESTED TO LODGE AN U.D. CASE IN CONNECTION WITH THE CUSTODIAL DEATH OF THE SAID CONVICT AND TO MAKE IMMEDIATE ARRANGEMENT FOR MAGISTRIAL INQUEST AND POST-MORTEM EXAMINATION ON THE DEAD BODY UNDER VIDEOGRAPHY AND TAKE OVER THE CHARGE ON THE DEAD BODY OF THE CONVICT AND ALSO REQUESTED TO MAKE OVER THE CHARGE TO THE NEAR RELETIVES ON COMPLETION OF ALL OFFICIAL PROCEDURES AS PER RULE. (.) NOW THE I/C HASTIGS POLICE STATION IS AGAIN REQUESTED FOR CONDUCTING MAGISTERIAL ENQUIRY BY A JUDICIAL/EXECUTIVE MAGISTRATE IN RESPECT OF THIS CUSTODIAL DEATH FOLLOWING THE EXISTING RULES IN CONSULTATION WITH CP, KOLKATA (.) I/C BHAWANIPORE PS/HASTINGS PS IS ALSO REQUESTED TO PRESERVE THE VISCERA OF THE DEAD BODY AND TO SEND THE SAME FOR FORENSIC/CHEMICAL EXAMINATION (.) THE PROFESSOR & HEAD OF THE DEPARTMENT, FORENSIC SCIENCE & STATE MEDICINE, IPGME & R AND SSKM HOSPITAL, KOLKATA IS HEREBY REQUESTED TO ARRANGE FOR PRESERVING THE DEAD BODY AND TO HANDOVER THE BODY OF DECEASED **CONVICT HARI SADHAN MALI (AGE ABOUT 96 YRS) S/O- LT. BASANTA KUMAR MALI, TO THE OFFICER-IN-CHARGE, BHAWANIPORE PS/HASTINGS POLICE STATION FOR HOLDING ALL LEGALITIES(.**

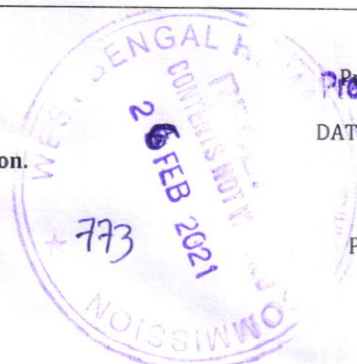
