P.C. which is mandatory in view of the order dated 04.09.2020 passed by NHRC.

The Director General of Correctional Services, West Bengal is also directed to submit a detailed report alongwith copy of Post Mortem report and Magisterial Inquest report etc. by 30.04.2021.

PURBA MEDINIPUR, SEND TO THE SSKM HOSPITAL ON 24.02.2021 AT 06.00PM AS LIFE SAVING MEASURE AND THE ONDUTY MEDICAL OFFICER OF THE SSKM HOSPITAL DECLARED BROUGHT DEATH AT 06.15PM (.)THE SAID CONVICT WAS RECIEVED FROM MIDNAPORE CENTRAL CORRECTIONAL HOME ON 20.02.2021 FOR BETTER MEDICAL TREATMENT. THE SAID CONVICT WAS CONVICTED BY THE LD. SESSION JUDGE, PURBA MEDINIPURE R.I. FOR LIFE IN CNNECTION WITH NANDAKUMAR P.S. CASE NO. 327/15 DTD. 13.7.2015 & S.T. CASE NO. 4/2016, U/S 395/397 IPC(.)

THE SAID CONVICT WAS SUFFERING FROM DYSNPOA WHEN RECEIVED FROM MIDNAPORE CENTRAL CORRECTIONAL HOME. THE SAID CONVICT WAS SENT TO SSKM HOSPITAL AS A LIFE SAVING MEASURE ON 20.02.2021. HE WAS DISCHARGED FROM THERE ON SAME DAY I.E. ON 20.02.2021 AND RETURNED INSIDE HOSPITAL NO.5. WHERE HE WAS FOLLOWED THE MEDICATIONS AS PRESCRIBED BY SSKM HOSPITAL (.)ON 24.02.2021, AS HIS CLINICAL CONDITION FURTHER DETERIORATED THE SAID PATIENT INMATE WAS ADMITTED TO SSKM HOSPITAL AS A LIFE SAVING MEASURE (.)

RECEIVED INFORMATION OVER TELEPHONIC MESSAGE AT ABOUT 18:15 HRS ON 24.02.2021 FROM THE ONDUTY GUARDING STAFF DETAILED AT SSKM HOSPITAL ON THE SAID CONVICT REGARDING HIS DEATH (.) THE I/C MAHISHADAL POLICE STATION IS REQUESTED TO INFORM THE MESSAGE TO HIS NEAR RELATIVES AND REQUEST THEM TO REMAIN PRESENT DURING MAGESTERIAL INQUEST , POST MORTEM EXAMINATION AND TO TAKE CHARGE OF THE DEAD BODY ON COMPLETION OF ALL LEGAL PROCEDURES (.) THE I/C HASTINGS PS IS REQUESTED TO LODGE AN U.D. CASE IN CONNECTION WITH THE CUSTODIAL DEATH OF THE SAID CONVICT AND TO MAKE IMMEDIATE ARRANGEMENT FOR MAGISTRIAL INQUEST AND POST-MORTEM EXAMINATION ON THE DEAD BODY UNDER VIDEOGRAPHY AND TAKE OVER THE CHARGE ON THE DEAD BODY OF THE CONVICT AND ALSO REQUESTED TO MAKE OVER THE CHARGE TO THE NEAR RELETIVES ON COMPLETION OF ALL OFFICIAL PROCEDURES AS PER RULE. NOW THE I/C HASTIGS POLICE STATON IS AGAIN REQUESTED FOR CONDUCTING MAGISTERIAL ENQUIRY BY A JUDICIAL/EXECUTIVE MAGISTRATE IN RESPECT OF THIS CUSTODIAL DEATH FOLLOWING THE EXISTING RULES IN CONSULTATION WITH CP, KOLKATA (.)
