The Deputy Commissioner of Police, South Division is directed to cause an enquiry and to submit a report by 30.04.2021 positively along with the enquiry report made by the Judicial Magistrate under section 176(1A) of the Cr. P.C. which is mandatory in view of the order dated 04.09.2020 passed by NHRC.

The Director General of Correctional Services, West Bengal is also directed to submit a detailed report alongwith copy of Post Mortem report and Magisterial Inquest report etc. by 30.04.2021.

This direction is to be communicated forthwith.

A.S(C) is also directed to take immediate steps for CRIS registration.

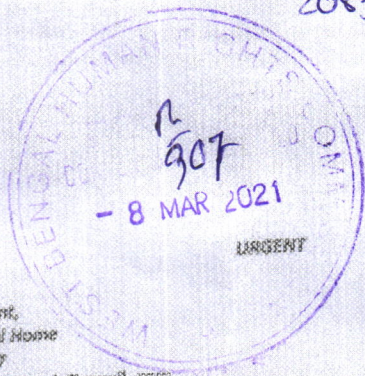
