P.C. which is mandatory in view of the order dated 04.09.2020 passed by NHRC.

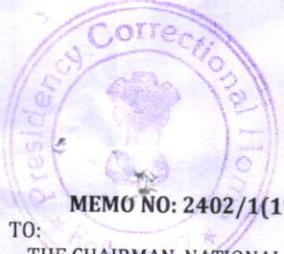

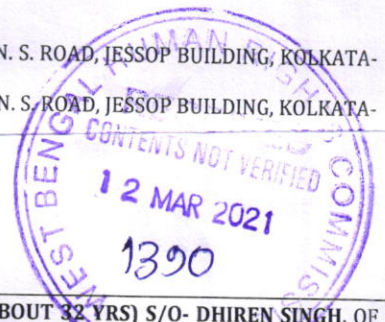

KOLKATA (.) THE SAID UTP WAS COMMITTED TO THIS CORRECTIONAL HOME ON 05 /03 /2021 ON TRANSFER FROM BARUIPUR CENTRAL CORRECTIONAL HOME FOR THE FACILITIES OF BETTER MEDICAL TREATMENT AND PENDING BEFORE THE LD. COURT OF ADDITIONAL CHIEF JUDICIAL MAGISTRATE, BARUIPUR, SOUTH 24 PARGANAS IN CONNECTION WITH KLC P.S. CASE NO. 19/21, DTD.-03/03/21 U/S- 46A (C)-XII WB EXCISE ACT. (.)

THE I/C K LC POLICE STATION IS REQUESTED TO INFORM THE NEAR RELATIVES OF THE SAID UTP AND REQUEST THEM TO REMAIN PRESENT DURING MAGERSTERIAL INQUEST , POST MORTEM EXAMINATION AND TO TAKE CHARGE OF THE DEAD BODY ON COMPLETION OF ALL LEGAL PROCEDURES (.) THE I/C HASTINGS PS IS REQUESTED TO LODGE AN U.D. CASE IN CONNECTION WITH THE CUSTODIAL DEATH OF THE SAID UTP AND TO MAKE IMMEDIATE ARRANGEMENT FOR MAGISTRIAL INQUEST AND POST-MORTEM EXAMINATION ON THE DEAD BODY UNDER VIDEOGRAPHY AND TAKE OVER THE CHARGE ON THE DEAD BODY OF THE UTP AND ALSO REQUESTED TO MAKE OVER THE CHARGE OF DEAD BODY TO THE NEAR RELETIVES ON COMPLETION OF ALL OFFICIAL PROCEDURES AS PER RULE. I/C BHAWANIPUR P.S. / HASTINGS P.S. IS ALSO REQUESTED TO PRESERVE THE VISCERA OF THE DEAD BODY AND TO SEND THE SAME FOR FORENSIC/CHEMICAL EXAMINATION (.) THE SUPERINTENDENT, S.S.K.M. HOSPITAL IS HEREBY REQUESTED TO ARRANGE FOR PRESERVE THE DEAD BODY AND TO HANDOVER THE BODY OF DECEASED UTP MITHUN SINGH (AGE ABOUT 32 YRS) S/O- DHIREN SINGH, TO THE OFFICER-IN-CHARGE, HASTINGS/ BHAWANIPUR POLICE STATION FOR HOLDING ALL LEGALITIES(.)
